

**The Borough of Weymouth and Portland  
(Waiting Restrictions) (Consolidation) Order 2011  
(as amended) (Amendment No.17 Order 2014)**

The Council of the Borough of Weymouth and Portland (hereinafter referred to as “the Council”) pursuant to arrangements made under Section 101 of the Local Government Act 1972 with the Council of the County of Dorset in exercise of its powers of the said County Council under Section 1, 2, 3, 4, 32, 35, 45-56 and Parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984 (“the Act of 1984”), the relevant powers under Part 6 of the Traffic Management Act 2004 and all other enabling powers, in accordance with the Local Authorities Traffic Orders (Procedure) (England and Wales) Regulations 1996 and after consultation with the Chief Officer of Police and with the consent of the County Council of Dorset in accordance with Section 39(3) of the Act of 1984, hereby makes the following Order which varies The Borough of Weymouth and Portland (Waiting Restrictions) (Consolidation) Order 2011 (as amended) hereinafter called “the Principal Order”.

1. This Order shall come into operation on Monday 7<sup>th</sup> July 2014 and may be cited as The Borough of Weymouth and Portland (Waiting Restrictions) (Consolidation) Order 2011 (as amended) (Amendment No.17 Order 2014).
2. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
3. Any document referring to the Principal Order shall be construed as referring to the Principal Order as amended by this Order.
4. The Principal Order shall be amended as follows:-
  - (1) In Schedule 3, Part 3.3 (Restricted Area Outside of a School, No Stopping between 8am and 5pm, Monday to Friday), **Insert** new as follows;

**“Lerret Road**

- (i) On its north west side, from a point 86.1 metres south west of its junction with Castle Road, south westwards for a distance of 31.6 metres.
- (ii) On its south east side, from a point 87.6 metres south west of its junction with Castle Road, south westwards for a distance of 31.8 metres.”

- (2) In Schedule 7, Part 7.5(i) (Designated Parking Spaces for the parking of Disabled Persons’ Vehicles Only) the **Amendments** detailed below are to be made under the roads named below:-

**Brisbane Road – Delete** in its entirety

**Dundee Road – Insert** new (iii) as follows;

- “(iii) On its east side, from a point 27.6 metres north of the boundary between numbers 64 and 66 Dundee Road, northwards for a distance of 6 metres.”

**Easton Street – Under (ii) (On its east side) Delete** (a) in its entirety and **Re-number** (b) as (a) accordingly.

**Radipole Lane – Delete** in its entirety

**St Georges Estate Road – Under (i) (On its east side) Delete (b) in its entirety**

**(3)** In Schedule 7, Part 7.5(i) (Designated Parking Spaces for the parking of Disabled Persons’ Vehicles Only) **Insert** the following:-

**“Maycroft Road**

(i) On its west side, from a point 1 metre south of the boundary between numbers 28 and 29 Maycroft Road, northwards for a distance of 6.6 metres.”

**“Pretoria Terrace**

(i) On its north side, from the boundary between numbers 7 and 8 Pretoria Terrace, westwards for a distance of 5.6 metres.”
