

**The Borough of Weymouth and Portland
(Waiting Restrictions) (Consolidation) Order 2011
(as amended) (Amendment No 19 Order 2015)**

The Council of the Borough of Weymouth and Portland (hereinafter referred to as "the Council") pursuant to arrangements made under Section 101 of the Local Government Act 1972 with the Council of the County of Dorset in exercise of its powers of the said County Council under Section 1, 2, 3, 4, 32, 35, 45-56 and Parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984"), the relevant powers under Part 6 of the Traffic Management Act 2004 and all other enabling powers, in accordance with the Local Authorities Traffic Orders (Procedure) (England and Wales) Regulations 1996 and after consultation with the Chief Officer of Police and with the consent of the County Council of Dorset in accordance with Section 39(3) of the Act of 1984, hereby makes the following Order which varies The Borough of Weymouth and Portland (Waiting Restrictions) (Consolidation) Order 2011 (as amended) hereinafter called "the Principal Order".

1. This Order shall come into operation on Monday 2nd March 2015 and may be cited as The Borough of Weymouth and Portland (Waiting Restrictions) (Consolidation) Order 2011 (as amended) (Amendment No 19 Order 2015).
2. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
3. Any document referring to the Principal Order shall be construed as referring to the Principal Order as amended by this Order.
4. The Principal Order shall be amended as follows:-
 - (1) In Schedule 3, Part 3.3 (Restricted Area Outside of a School, No Stopping between 8am and 5pm, Monday to Friday) **Delete** Clovens Road in its entirety.
 - (2) In Schedule 7, Part 7.5(i) (Designated Parking Spaces for the parking of Disabled Persons' Vehicles Only) the **Amendments** detailed below are to be made under the roads named below:-

Avalanche Road – Insert new (iv) as follows;

- "(iv) On its east side, from a point 0.6 metres north of the boundary between numbers 86 and 88 Avalanche Road, southwards for a distance of 4.5 metres."

Brownlow Street – **Delete** in its entirety

Chickerell Road – Under (i) (On its south side) **Insert** new (b) as follows;

- "(b) From a point 3.1 metres west of the boundary between numbers 29 and 31 Chickerell Road, westwards for a distance of 6.6 metres."

Cromwell Road – Delete (ii) in its entirety

Dorchester Road – Under (i) (On its west side) **Delete** (a) in its entirety and **Re-number** existing (b) as (a) accordingly.

Dumbarton Road – Delete (ii) in its entirety.

Easton Street – Delete (ii) (On its east side) in its entirety.

Granby Close – Under (iii) (On its north west side) **Delete** (b) and (c) in their entirety and **Re-number** existing (d) as (b) accordingly.

Khartoum Road – Under (i) (On its east side) **Delete** (b) in its entirety.

Moorfield Road – Insert new (ii) as follows;

“(ii) On its south side, from a point 1.5 metres west of the boundary between numbers 38 and 40 Moorfield Road, westwards for a distance of 4.5 metres.”

Ranelagh Road – Under (i) (On its west side) **Delete** (c) and (d) in their entirety.

St Pauls Road – Delete in its entirety.

(3) In Schedule 7, Part 7.5(i) (Designated Parking Spaces for the parking of Disabled Persons' Vehicles Only) **Insert** the following:-

“Station Road

(i) On its west side, from a point 17 metres south of its junction with Reforme, southwards for a distance of 6 metres.”
