**(AMENDMENT No.106) ORDER 2023**

**ROAD TRAFFIC REGULATION ACT 1984**

The KENT COUNTY COUNCIL, acting as the Local Traffic Authority and in exercise of its powers under Sections 1(1), 2(1) to (3), 3(2), 4(1) and (2), 32(1), 35(1), 45, 46, 49, 53, 122 and 124 of the Road Traffic Regulation Act 1984 (hereinafter called "the Act") and all other enabling powers, after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Schedule 9 to the Act, hereby make the following Order:-

**Revocations, Modifications and Amendments**

In this Order the expression "Order of 2005" means "The Kent County Council (Various Roads, Dover District) (Waiting Restrictions and Street Parking Places) Order 2005". The Order of 2005 shall have effect as though:

**In the Schedule to the Order of 2005**

**SCHEDULE 1.00**  
**NO WAITING AT ANY TIME**

**Roads in Wingham in the District of Dover**

The following to be inserted in to the First Schedule of the Order of 2005 in correct alphabetical sequence:

**GOBERY HILL**           (1) On southeast side from its junction with High Street to a point 18 meters northeast of the boundary of 116/117 High Street.

(2) On the northeast side from its junction with Preston Hill for a distance of 13 metres in a north easterly direction.

The following entry to be inserted to the First Schedule of the Order of 2005 in place of the existing entry:-

**HIGH STREET**           (1) On the western side  
  
(a) from a point 42 metres north of the southern wall of 50 High Street to a point 55 metres south of its junction with Staple Road;

(b) from a point 10 metres north of the centre line of North Court Road southwards for a distance of 20 metres.

(2) On the east side from a point 1 metre south of the southern boundary of 41 High Street to a point 55 metres south of its junction with Staple Road;

(3) On northeast side from its junction with Preston Hill to a point opposite and in line with the southwestern building line of 106 High Street.

(4) On the southeast side from its junction with Gobery Hill to the southwestern building line of 106 High Street.

The following to be inserted in to the First Schedule of the Order of 2005 in correct alphabetical sequence:

- PRESTON HILL (1) On the east side from its junction with Gobery Hill to a point opposite and in line with the boundary of 1/2 Preston Hill.
- (2) On the west side form its junction with High Street to a point in line with the boundary of 1/2 Preston Hill.

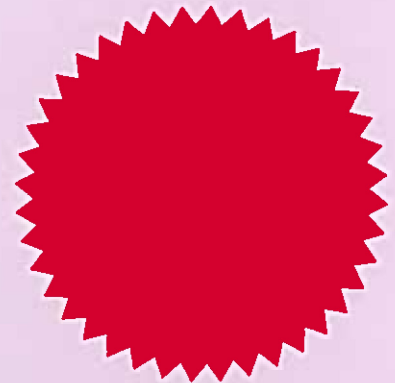
