

**THE KENT COUNTY COUNCIL
(VARIOUS ROADS, DOVER DISTRICT)
(WAITING RESTRICTIONS AND STREET PARKING PLACES)
(AMENDMENT No.117) ORDER 2024**

ROAD TRAFFIC REGULATION ACT 1984

The KENT COUNTY COUNCIL, acting as the Local Traffic Authority and in exercise of its powers under Sections 1, 2, 3, 4, 5, 19, 32, 35, 36, 45, 46, 49, 51, 53, 124 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ('the Act') and all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

Revocations, Modifications and Amendments

In this Order the expression "Order of 2005" means "The Kent County Council (Various Roads, Dover District) (Waiting Restrictions and Street Parking Places) Order 2005" shall have effect as though:

**SCHEDULE 1.00
NO WAITING AT ANY TIME**

Roads in Capel-le-Ferne in the District of Dover

The following entry to be inserted to the First Schedule of the Order of 2005 in correct alphabetical sequence:-

- ALBERT ROAD**
- (1) On the east side from its junction with New Dover Road for a distance of 17.5 metres in a southerly direction.
 - (2) On the west side from its junction with New Dover Road for a distance of 22.7 metres in a southerly direction.

The following entry to be inserted to the First Schedule of the Order of 2005 in place of the existing entry:-

- ALEXANDRA ROAD**
- (1) On the northeast side from its junction with Capel Street for a distance of 11 metres in an easterly direction.
 - (2) On the southwest side from its junction with Capel Street for a distance of 9 metres in an easterly direction.
 - (3) On the east side of its junction with New Dover Road between points 14.3 metres north and 12.9 metres south.
 - (4) On the west side of its junction with New Dover Road between points 14.8 metres north and 10.8 metres south.

The following entry to be inserted to the First Schedule of the Order of 2005 in correct alphabetical sequence:-

P/15/08/2024/D/2218

- AVONDALE ROAD** (1) On the east side of its junction with New Dover Road between points 11.9 metres north and 14.3 metres south.
- (2) On the west side of its junction with New Dover Road between points 11.8 metres north and 10 metres south.

The following entry to be inserted to the First Schedule of the Order of 2005 in correct alphabetical sequence:-

- CLARENCE ROAD** (1) On the east side of its junction with New Dover Road between points 20.7 metres north and 11.6 metres south.
- (2) On the west side of its junction with New Dover Road between points 14.6 metres north and 20.7 metres south.

The following entry to be inserted to the First Schedule of the Order of 2005 in correct alphabetical sequence:-

- HELENA ROAD** (1) On the east side of its junction with New Dover Road between points 10 metres north and 13.3 metres south.
- (2) On the west side of its junction with New Dover Road between points 12.1 metres north and 10.2 metres south.

The following entry to be inserted to the First Schedule of the Order of 2005 in correct alphabetical sequence:-

- NEW DOVER ROAD** (1) On the south side
- (a) between points 1 metre east and 1.8 metres west of its junction with Albert Road;
 - (b) between points 1.2 metres east and 1.4 metres west of its junction with Alexandra Road;
 - (c) between points 1.7 metres east and 1.4 metres west of its junction with Avondale Road;
 - (d) between points 1 metre east and 2 metres west of its junction with Clarence Road;
 - (e) between points 3 metres east and 1.2 metres west of its junction with Helena Road;
 - (f) between points 7 metres east and 1.6 metres west of its junction with Victoria Road.
- (2) On the north side
- (a) between points 1.1 metres east and 1.2 metres west of its junction with Alexandra Road;
 - (b) between points 1.2 metres east and 1.2 metres west of its junction with Avondale Road;

(c) between points 2 metres east and 1.4 metres west of its junction with Clarence Road;

(d) between points 1.2 metres east and 1.9 metres west of its junction with Helena Road;

(e) between points 1.6 metres east and 1.4 metres west of its junction with Victoria Road.

The following entry to be inserted to the First Schedule of the Order of 2005 in correct alphabetical sequence:-

OLD DOVER ROAD (1) On the north side of the western junction with New Dover Road for a distance of 17.5 metres in an easterly direction.

(2) On the west side of the eastern junction with New Dover Road for a distance of 20 metres in a southerly then a westerly direction.

(3) On the south side

(a) of the western junction with New Dover Road for a distance of 32 metres in an easterly direction;

(b) of the eastern junction with New Dover Road for a distance of 49 metres in a westerly direction.

The following entry to be inserted to the First Schedule of the Order of 2005 in correct alphabetical sequence:-

VICTORIA ROAD (1) On the east side of its junction with New Dover Road between points 17.4 metres north and 13 metres south.

(2) On the west side of its junction with New Dover Road between points 11 metres north and 15.5 metres south.

This Order may be cited as "The Kent County Council (Various Roads, Dover District) (Waiting Restrictions and Street Parking Places) (Amendment No.117) Order 2024" ("this Order") and shall come into operation on the 16th day of August 2024.
