Roads in Dover in the District of Dover

The following entry to be inserted in to the First Schedule of the Order of 2005 in place of the existing entry:--

CHARLTON GREEN

- (1) On the northeastern side
- (a) from its junction with Frith Road for a distance of 4 metres in a north westerly direction;
- (b) from its junction with Frith Road for a distance of 30 metres in a south easterly direction;
- (c) from its junction with Maison Dieu Road for a distance of 56 metres in north westerly direction;
- (d) between points 35 metres and 45 meters south-east of the junction with Beaconsfield Avenue;
- (e) from a point opposite 25 metres northwest of the southeastern boundary of numbers 71 to 75 north westwards for a distance of 22.5 metres.
- (2) On the southwestern side
- (a) from its junction with Bridge Street to Maison Dieu Road;
- (b) from a junction with Bridge Street for a distance of 45.7 metres in a north westerly direction.
