**(WAITING RESTRICTIONS AND STREET PARKING PLACES)**  
**(AMENDMENT No.98) ORDER 2022**

**ROAD TRAFFIC REGULATION ACT 1984**

The KENT COUNTY COUNCIL, acting as the Local Traffic Authority and in exercise of its powers under Sections 1(1), 2(1) to (3), 3(2), 4(1) and (2), 32(1), 35(1), 45, 46, 49, 53, 122 and 124 of the Road Traffic Regulation Act 1984 (hereinafter called "the Act") and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Schedule 9 to the Act, hereby make the following Order:-

**Revocations, Modifications and Amendments**

In this Order the expression "Order of 2005" means "The Kent County Council (Various Roads, Dover District) (Waiting Restrictions and Street Parking Places) Order 2005". The Order of 2005 shall have effect as though:

**In the Schedules to the Order of 2005**

**SCHEDULE 1.00**  
**NO WAITING AT ANY TIME**

**Roads in Sandwich in the District of Dover**

The following entry to be inserted in to the First Schedule of the Order of 2005 in correct alphabetical sequence:

**BURCH AVENUE**      On both sides from its junction with St Barts Road for a distance of 12.5 metres in a northerly direction.

The following to be inserted in to the First Schedule of the Order of 2005 in place of the existing entries:

**FORDWICH PLACE**    (1) On east side from its junction with St Barts Road for a distance of 38 metres in a northerly direction.

(2) On the west side from its junction with St Barts Road for a distance of 101 metres in a northerly direction.

The following to be inserted in to the First Schedule of the Order of 2005 in place of the existing entries:

**SANDOWN ROAD**    (1) On the north side

(a) from its junction with Knightrider Street eastwards for 15 metres;

(b) from a point 65 metres east of its junction with Knightrider Street to a point 10 metres east of its junction with Manwood Road.

(2) On the southern side

P/12/01/2023/DOV/2105

- (a) from its junction with Knightrider Street eastwards to a point 24 metres east of its junction with Manwood Road;
- (b) from the western boundary wall of Herald Cottage for a distance of 35 metres in a westerly direction;
- (c) from a point 63 metres west of its junction with St Georges Road for a distance of 20 metres in a westerly direction;
- (d) from its junction with St Georges Road for a distance of 10 metres in a westerly direction.

The following to be inserted in to the First Schedule of the Order of 2005 in place of the existing entries:

**ST BART'S ROAD** (1) On both sides

- (a) from its junction with Woodnesborough Road south eastwards for 30 metres;
  - (b) from its junction with Dover Road to a point in line with the boundary of 133/135 St Barts Road.
- (2) On the north side from its junction with Burch Avenue to a point 19 metres east and to a point 23 metres west.

The following to be inserted in to the First Schedule of the Order of 2005 in place of the existing entries:

**ST GEORGE'S ROAD**

(1) On the northern side

- (a) from a point 13.5 metres east of the centre line of the eastern arm of St George's Lees to a point 13.5 metres west of the centre line of the eastern arm of St George's Lees;
- (b) from a point 13.5 metres east of the centre line of the eastern arm of St George's Lees eastwards and south eastwards to a point 20 metres southeast of the centre line of Manwood Road.

(2) On both sides

- (a) from its junction with New Street to a point 10 metres east of the junction with the western arm of St Georges Lees;
- (b) from its junction with Sandown Road to a point in line with the northern boundary of 164 St Georges Road.

- (3) On the southern side from a point 20 metres east of the centre line of the eastern arm of St George's Lees eastwards and south eastwards to a point 12 metres northwest of the centre line of Manwood Road;

The following entry to be inserted in to the First Schedule of the Order of 2005 in correct alphabetical sequence:

WHITEFRIARS WAY (1) On the east side from its junction with Whitefriars Meadow for a distance of 11 metres in a northerly direction.

(2) On the west side from its junction with Whitefriars Meadow for a distance of 10 metres in a northerly direction.

**SCHEDULE 2.40  
NO WAITING 7AM-7PM**

The following to be inserted in to the Second Schedule of the Order of 2005 in correct alphabetical sequence:

**ST GEORGE'S ROAD**

(1) On the northeast side

(a) from the boundary of 19/21 St Georges Road to the boundary of 33/35 St Georges Road;

(b) from a point 28 metres from its junction with Sandown Road for a distance of 287 metres in a south westerly direction.

(2) On the south side from the boundary of 80/82 St Georges Road to the boundary of 106/108 St Georges Road.

This Order may be cited as "The Kent County Council (Various Roads, Dover District) (Waiting Restrictions and Street Parking Places) (Amendment No.98) Order 2022" ('this Order') and shall come into operation on the 13th day of January 2023.
