



**THE KENT COUNTY COUNCIL  
(VARIOUS ROADS, DOVER DISTRICT) (WAITING RESTRICTIONS AND  
STREET PARKING PLACES) (No. 1) ORDER 2006**

The Kent County Council, in exercise of their powers under sections 1(1), 2(1) to (3), 3(2), 4(1) and (2), 32(1), 35(1), 45, 46, 49, 53 and 124 of the Road Traffic Regulation Act 1984 and of all other enabling powers, and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

A. the Kent County Council (Various Roads, Dover District) (Waiting Restrictions and Street Parking Places) Order 2005 Shall have effect as though:

**In the Schedules to the Order**

**Roads in Aylesham**

**OAKSIDE ROAD**

The following to be added

**OAKSIDE ROAD**      On both sides  
from the junction with Vale View Road for a distance of 10 metres in a south-  
westerly direction

**VALE VIEW ROAD**

The following to be added

**VALE VIEW ROAD**      On the south-western side  
from the junction with Oakside Road for a distance of 10 metres in a south-  
easterly direction;

**Roads in Deal**

**COURT ROAD**

The following to be added to the First Schedule in correct alphabetical sequence -

**COURT ROAD**      On both sides  
from its junction with Station Road to a point 4 metres south of the southern  
building line of 56 Court Road

**MAYERS ROAD**

The following to be inserted in the First Schedule in place of the existing entry -

**MAYERS ROAD**      On both sides  
  
from a point in line with the boundary wall of nos. 74/76 southwards to a point  
in line with the boundary wall of nos. 80/82  
  
from its junction with Station Road southwards for a distance of 10 metres



## STATION ROAD

The following to be inserted in the First Schedule in place of the existing entry -

### STATION ROAD

On both sides

from points opposite and in line with the boundary between Nos. 81/83 Station Road westwards for a distance of 46 metres

On the northern side

from its junction with Dover Road in a westerly direction to a point in line with the boundary between Nos. 6/8 Station Road

On the southern side

from its junction with Dover Road in a westerly direction to a point in line with the eastern boundary of No. 9 Station Road

B. This Order may be cited as Kent County Council (Various Roads, Dover District) (Waiting Restrictions and Street Parking Places) (No. 1) Order 2006 and shall come into operation on the 5<sup>th</sup> day of July, 2006.
