THE KENT COUNTY COUNCIL
(VARIOUS ROADS, DOVER DISTRICT) (WAITING RESTRICTIONS AND
STREET PARKING PLACES) (AMENDMENT No. 10) ORDER 2009

The Kent County Council, in exercise of their powers under sections 1(1), 2(1) to (3), 3(2), 4(1) and (2), 32(1), 35(1), 45, 46, 49, 53 and 124 of the Road Traffic Regulation Act 1984 and of all other enabling powers, and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

A. The Kent County Council (Various Roads, Dover District) (Waiting Restrictions and Street Parking Places) Order 2005 Shall have effect as though:

In the Articles of the Order

(a) Article 9 shall be deleted and replaced with

DAYTIME WAITING RESTRICTIONS

9. SAVE as provided in Part H of this Order no person shall, except upon the direction or with the permission of a police constable in uniform or with the permission of a parking attendant, cause or permit any vehicle to wait in any restricted road or length of restricted road described in Schedules 2.00, 2.11, 2.16, 2.20, 2.30, 2.40 and 2.50 to this Order between the times and on the days specified in those Schedules.

In the Schedules to the Order

the following shall be added as Schedule 2.50

"WAITING PROHIBITED BETWEEN 8.00AM - 6.30PM"

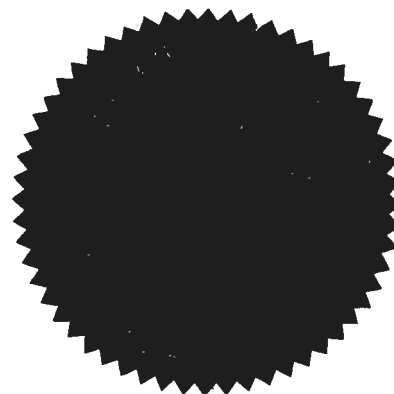
