

THE KENT COUNTY COUNCIL
(VARIOUS ROADS, DOVER DISTRICT) (WAITING RESTRICTIONS AND
STREET PARKING PLACES) (AMENDMENT No. 8) ORDER 2012

The Kent County Council, in exercise of their powers under sections 1(1), 2(1) to (3), 3(2), 4(1) and (2), 32(1), 35(1), 45, 46, 49, 53 and 124 of the Road Traffic Regulation Act 1984 and of all other enabling powers, and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

A. The Kent County Council (Various Roads, Dover District) (Waiting Restrictions and Street Parking Places) Order 2005 Shall have effect as though:

In the Articles of the Order -

Limited Waiting Parking places

the following shall replace Article 37

37 SAVE as provided in Part H of this Order no person shall, except upon the direction or with the permission of a police constable in uniform or of a Parking Attendant, cause or permit any vehicle to wait in any parking place described in the numbered Schedule referred to in column 1 of the Table to this Article on the days and between the times (hereinafter referred to as "the said hours") specified in the corresponding column 3 of that item

(i) for a longer period than that specified in the corresponding column 4, or

(ii) if a period of less than the time specified in the corresponding column 5 has elapsed since the termination during the said hours of the last period of waiting (if any) of the vehicle in that length of road.

Residents' Shared Parking places

the following shall replace Article 41

- 41 SAVE as provided in Part H of this Order no person shall, except upon the direction or with the permission of a police constable in uniform or of a parking attendant, cause or permit any vehicle, other than a vehicle which is displaying in the relevant position

(i) a valid Parking Permit issued, or

(ii) a valid Visitors' Parking Permit validated in respect of that vehicle for the Zone in which that Parking Place is situated,

to wait in any parking place described in the numbered Schedule referred to in column 1 of the Table to this Article on the days and between the times (hereinafter referred to as "the said hours") specified in the corresponding column 3 of that item

(i) for a longer period than that specified in the corresponding column 4, or

(ii) if a period of less than the time specified in the corresponding column 5 has elapsed since the termination during the said hours of the last period of waiting (if any) of the vehicle in that length of road.

BEACONSFIELD ROAD

The following to be inserted in Schedule 1.00 (No waiting at any time) in place of the existing entry -

BEACONSFIELD ROAD

North side - from the junction with Blenheim Road to a point in line with the boundary of 10/12 Beaconsfield Road.

North side - from the junction with Victoria Road for a distance of 50 metres in a westerly direction.

South side - from the junction with Blenheim Road for a distance of 20 metres in an easterly direction.

South side - from the junction with Victoria Road to a point in line with the boundary of 9a/11 Beaconsfield Road.

The following to be inserted in Schedule 3.21 – (Limited Waiting Mon-Sat 8.30am-5.30pm - 2 hours limit - no return for 1 hour - Except for Permit Holders) in correct alphabetical sequence -

BEACONSFIELD ROAD

North side - From the boundary of 10/12 Beaconsfield Road to a point 50 metres west of the junction with Victoria Road.

South side - from a point 20 metres east of the junction with Blenheim Road to a point in line with the boundary of 9a/11 Beaconsfield Road.

BLLENHEIM ROAD, DEAL

The following to be inserted in Schedule 3.21 – (Limited Waiting Mon-Sat 8.30am-5.30pm - 2 hours limit - no return for 1 hour - Except for Permit Holders) - in correct alphabetical sequence -

BLLENHEIM ROAD, DEAL

South-eastern side (opposite 15-19 Blenheim Road) from the junction with Wellington Road for a distance of 27 metres in a south-westerly direction.

West side - from a point in line with the northern boundary of 23 Blenheim Road for a distance of 25 metres in a northerly direction.

West side - from a point in line with the southern boundary of 23 Blenheim Road for a distance of 213 metres in a southerly direction.

GILFORD ROAD

The following to be inserted in Schedule 3.21 – (Limited Waiting Mon-Sat 8.30am-5.30pm - 2 hours limit - no return for 1 hour - Except for Permit Holders) - in correct alphabetical sequence -

GILFORD ROAD

North side - from a point in line with the boundary of 48/50 Gilford Road to a point in line with the boundary of 64/66 Gilford Road.

South side - from a point 49 metres west of the junction with Victoria Road to a point in line with the boundary of 43/45 Gilford Road.

HOPE ROAD

The following to be inserted in Schedule 1.00 (No waiting at any time) in place of the existing entry -

HOPE ROAD (EAST-WEST ARM)

North side -

(a) from the junction with Blenheim Road for a distance of 9 metres in an easterly direction.

(b) from a point in line with the west boundary of 1 Hope Road eastwards to the eastern extremity.

South side - from the junction with Blenheim Road for a distance of 11 metres in an easterly direction.

South side - from the junction with the north-south arm to a point in line with the boundary of 10/11 Hope Road.

HOPE ROAD (NORTH-SOUTH ARM)

On both sides for the entire length

HOPE ROAD (SLIP ROAD TO NORMAN TAILYOUR HOUSE)

East side - from the junction with Hope Road (east - west arm) for a distance of 5 metres in a northerly direction.

West side - for the entire length

The following to be inserted in Schedule 3.21 - (Limited Waiting Mon-Sat 8.30am-5.30pm - 2 hours limit - no return for 1 hour - Except for Permit Holders) in correct alphabetical sequence -

HOPE ROAD

South side - from a point opposite the boundary of 10/11 Hope Road for a distance of 20 metres in a westerly direction.

Entrance to Norman Tailyour House.

East side - from a point 5 metres north of the junction with Hope Road (east - west arm) for a distance of 16 metres in a northerly direction.

CHERRY TREE AVENUE

the following to be deleted from Schedule 3.40 - (Limited Waiting Mon-sat 8.30am-5.30pm 1 hour in any period of 3 hours)

CHERRY TREE AVENUE

On the eastern side from a point 54 metres north-east of its junction with London Road to a point in line with the boundary of Nos. 11-13

Roads in St Margarets-at-Bay

HIGH STREET

the following to be inserted in Schedule 3.11 (limited waiting 30min in 4 - Mon-Sat - 8.30am-5.30pm) in correct alphabetical sequence -
