In the Table to Article 83 [PARKING CHARGES] the entry in column 5 [Chargeable hours] will be amended as follows -

in Items 1, 2, and 3 the expression - "9am to 6pm on all days" to be amended to read "9am to 5pm on all days"

in Items 4, 5, and 6 the expression - "9am to 6pm on Mondays to Saturdays" to be amended to read "9am to 5pm on Mondays to Saturdays"
