ROAD TRAFFIC REGULATION ACT 1984

The KENT COUNTY COUNCIL, acting as the local traffic authority and in exercise of its powers under Sections 1(1), 2(1) to (3), 3(2), 4(1) and (2), 32(1), 35(1) and 124 of the Road Traffic Regulations Act 1984 (hereinafter called "the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Schedule 9 to the said Act of 1984, hereby makes the following Order:-

REVOCATION, MODIFICATION AND AMENDMENTS

1. The Kent County Council (Various Roads, Dover District) (Waiting Restrictions and Street Parking Places) (Amendment 19) Consolidation Order 2013 to be amended as follows:-
2. The Order of 2013 shall have effect as though
 - a) In Part 3 thereto, the lengths of road specified in Schedule 1 to this Order to be deleted.
 - b) In Part 3 thereto, the lengths of road specified in Schedule 2 to this Order to be inserted in the correct order

In Schedule 1 the following to be deleted from the Order of 2013

SCHEDULE 1

SHOLDEN NEW ROAD

On the north-western side

From its junction with London Road for a distance of 38 metres in a north-easterly direction

In Schedule 1 the following to be added to the Order of 2013

SCHEDULE 2

No waiting at any time

SHOLDEN NEW ROAD On the north western side

From its junction with London Road north eastwards for a distance of 75 metres

From a point 154 metres northeast of its junction with London Road north eastwards for a distance of 23 metres

SHOLDEN NEW ROAD On the north western side

(SHOLDEN FIELDS SOUTH WESTERN EMERGENCY ACCESS) From its junction with Sholden New Road north westwards for a distance of 5.7 metres
