(AMENDMENT No.82) ORDER 2021**

**ROAD TRAFFIC REGULATION ACT 1984**

The KENT COUNTY COUNCIL, acting as the Local Traffic Authority and in exercise of its powers under Sections 1(1), 2(1) to (3), 3(2), 4(1) and (2), 32(1), 35(1), 45, 46, 49, 53, 122 and 124 of the Road Traffic Regulation Act 1984 (hereinafter called "the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Schedule 9 to the Act, hereby make the following Order:-

**Revocations, Modifications and Amendments**

In this Order the expression "Order of 2005" means "The Kent County Council (Various Roads, Dover District) (Waiting Restrictions and Street Parking Places) Order 2005" ('the Order of 2005') shall have effect as though:

**SCHEDULE 1.00  
NO WAITING AT ANY TIME**

**Roads in Sandwich in the District of Dover**

The following entry to be added to the First Schedule of the Order of 2005 in correct alphabetical sequence:-

ALLISS GARDENS On both sides of its junction with Dover Road for a distance of 12 meters in a north westerly direction.

The following entries to be inserted in to the First Schedule of the Order of 2005 in place of the existing entries:-

DOVER ROAD (1) On south west side

(a) from the junction with Deal Road (A258) to a point 20 metres south west of the junction with Stone Cross Lees;

(b) from a point opposite and in line with the southern boundary of number 119 Dover Road for a distance of 23.4 metres in a north easterly direction.

(2) On the north west side

(a) from the junction with Deal Road (A258) for a distance of 40 metres in a south westerly direction;

(b) from the junction with Stone Cross Lees for a distance of 20m in a south westerly direction and 20m in a north westerly direction;

(c) from a point in line with the south western boundary wall of No. 47 Dover Road for a distance of 15 metres in a north easterly direction;

(d) from a point in line with the boundary of number 65/67 Dover Road for a distance of 15 metres in a south westerly direction;

(e) from the junction with Alliss Gardens to a point 39 metres south west and to a point 38 metres north east.

(3) On the west side from the southern kerbline junction with St Bartholomews for a distance of 10 metres in a southerly direction.

This Order may be cited as "The Kent County Council (Various Roads, Dover District) (Waiting Restrictions and Street Parking Places) (Amendment No.82) Order 2021" ('this Order') and shall come into operation on the 14th day of May 2021.
