General

Purpose of Amendments

- Ashdale Road: south western side of the road, from a point approx. 11 metres north
 west of its junction with Park Avenue, in a south easterly direction for a distance of
 approx. 22 metres. Plan CR171 refers.
- 8. Park Avenue: both sides of the road, from its junction with Ashdale Road, in a south westerly direction for a distance of approx. 9 metres. Plan CR 171 refers.
- B6308 Medomsley Road: eastern side of the road, from a point approx. 11 metres south of its junction with Ashdale Road in a southerly direction for a distance of approx.
 9 metres. Plan CQ172 refers.
- A691 Villa Real Road: south eastern side of the road, from its roundabout junction with the B6308 Medomsley Road, in a south easterly direction, for a distance of approx. 425 metres. Plans CR172 & CR173 refer.
- 11. A691 Villa Real Road: north eastern side of the road, from a point of approx. 13 metres northwest of its junction with the Unc Balmoral Grove, in a south easterly direction for a distance of approx. 25 metres. Plan CR173 refers.
- 12. Balmoral Grove: both sides of the road, from its junction with the A691 Villa Real Road, in a north easterly direction for a distance of approx. 1 metre. Plan CR173 refers.
- 13. A691 Villa Real Road: north western side of the road, from a point of approx. 6 metres northwest of its junction with Unnamed access road leading to Walton Terrace and Bramwell Terrace, in a south easterly direction for a distance of approx. 13 metres. Plan CR173 refers.
- 14. Unnamed access road leading to Walton Terrace / Bramwell Terrace: both sides of the road from its junction with the A691 Villa Real Road, in a north easterly direction, for a distance of approx. 3 metres. Plan CR173 refers.
- 15. Unnamed access road leading to Walton Terrace / Bramwell Terrace: on western side of the road from a point 4 metres north of its junction with the Unc Bramwell Terrace, in a southerly direction, for a distance of approx. 13 metres. Plan CR173 refers.
- 16. Bramwell Terrace: northern side of the road, from its junction with the unnamed access road leading to Walton Terrace / Bramwell Terrace, in a westerly direction for a distance of approx. 4 metres. Plan CR173 refers.
- 17. Bramwell Terrace: southern side of the road, from its junction with the unnamed access road leading to Walton Terrace / Bramwell Terrace, in a westerly direction for a distance of approx. 2 metres. Plan CR173 refers.
