General

Purpose of Amendments

The following brief synopsis of amendments should be viewed in conjunction with the plans identified within the Schedules to the above Order, however the plan(s) should prevail in the event of any discrepancy:

- (A) Introduction of a No Waiting At Any Time restriction on Station Road, from the junction of Christchurch Court, running in a westerly direction to the junction with Byron Terrace (B1285). Plans EX165, EX166 and EY166 refer.
- (B) Introduction of a No Stopping on School Entrance Markings restriction at the entrance of the Seaham School of Technology on B1285 Station Road. Plan EX166 refers.
- (C) Introduction of a Disabled Badge Holders only Parking Place at Seaham Train Station on the south side of New Drive (adj No. 46).
- (D) Introduction of restricted Parking Place Mon-Sat 8am-6pm 20 mins No return within 1 hour at Seaham Train Station on the north side of New Drive.
