

THE COUNTY COUNCIL OF DURHAM (CHESTER-LE-STREET AND BIRTLEY) (PARKING & WAITING RESTRICTIONS) CONSOLIDATION NO.3 ORDER 2015 (AMENDMENT NO. 1) ORDER 2015

The County Council of Durham ("the Council") in exercise of their powers under Sections 1, 2, 4, 32, 35, 45, 46, 46A, 47. & 49 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended ("the Act") and Part 6 of the Traffic Management Act 2004, as amended and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

General

This Order may be cited as The County Council of Durham (Chester-le-Street and Birtley) (Parking & Waiting Restrictions) Consolidation No. 3 Order 2015 (Amendment No. 1) Order 2015 and shall come into operation on the 1st day of February 2016.

The under-noted amendments have been made to the following Order:

Purpose of Amendments

The following brief synopsis of amendments should be viewed in conjunction with the plans identified within the Schedules to the above Order, however the plan(s) should prevail in the event of any discrepancy:

- Introduce permit holder only parking Mon-Sat 10am-11am & 2pm-3pm on the north side of Bullion Lane.
- Introduce no waiting at any time restrictions on the junction of Bullion Lane, Station Rd and the access road to Sanders Memorial Homes.
- Introduce no waiting at any time on the south side of Bullion Lane across the junction of the access road to Newker Cottage.
- 4. Remove the existing no waiting at any time restrictions in front of the newly constructed pay and display parking bays on Burns Green.

SCHEDULES
