



The County Council of Durham (Durham City)(Off Street Parking Places) Order 2008 (Amendment No.1) Order 2021

The County Council of Durham ("the Council") in exercise of their powers under Sections 1, 2, 4, 32, 33, 35, 35A, 35B, 35C and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, as amended, ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

PART I

General

This Order may be cited as The County Council of Durham (Durham City) (Off Street Parking Places) Order 2008 (Amendment No 1) Order 2021 and shall come into operation on 23rd Day of September 2021.

PART II

Amendment to Principle Order

The following Order is to be amended: The County Council of Durham (Durham City) (Off Street Parking Places) Order 2008

1. Amendments

a) Article 2 (Interpretation)

New definitions have been inserted which read:

"pool car" a company vehicle that's available for use by one or more employees of the council

"council" means The County Council of Durham

"electric vehicle" means a vehicle in which the electrical motive power is derived from an electrical storage battery;

"recharging post" means a device designed for the recharging of electric vehicles;

"permit holders" means a person to whom a parking permit has been issued under the provisions of Article 6 of this Order;

"goods vehicle" has the same meaning as that ascribed to it in Schedule 6 of the Road Traffic Act 1988 ('RTA 1988');

"loading bay" means an area of highway designated as a loading bay under the provisions of this Order;

b) Article 6 - Conditions of Use of Parking Places

New items 11, 12, 13 and 14 have been inserted which read:

11) no person shall cause or permit a vehicle to wait or park in a parking bay marked for electric vehicles unless the vehicle is an electric vehicle.

12) no person shall cause or permit a vehicle to wait or park in a parking bay marked for pool cars unless the vehicle is a pool car registered to the council

13) no person shall cause or permit any vehicle to wait or park in a parking bay marked for permit holders only unless the vehicle displays in the relevant position a valid permit issued by the Council's Parking & Transport Infrastructure team.

14) no person shall cause or permit any vehicle to wait or park in a parking bay marked for loading only unless the vehicle is being used for the purposes of loading or unloading goods.

2.Schedule

New items four and five have been inserted into to Schedule 1 of this Order the effect of which is to introduce the Milburngate and The Sands multi storey car parks (the location of which is shown on the plan attached to this order), which reads:

2. Insofar as any provision of this Order conflicts with any provision which is contained in an Order made or having effect as if made under the Act or by or under any other enactment then the provisions of THIS Order shall prevail.
3. The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act or by so under any other enactment.

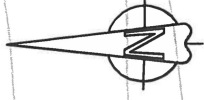




Market Permit Holders Only
