THE COUNTY COUNCIL OF DURHAM (SPENNYMOOR) (PROHIBITION OF WAITING & STOPPING, RESTRICTION OF WAITING, LOADING/UNLOADING & PARKING PLACES) ORDER 2011 (AMENDMENT NO. 1) ORDER 2022

The County Council of Durham ("the Council") in exercise of their powers under Sections 1, 2, 4, 32 and 35 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

Part 1

1. General

This Order may be cited as The County Council of Durham (Spennymoor) (Prohibition of Waiting & Stopping, Restriction of Waiting, Loading/Unloading & Parking Places) Order 2011 (Amendment No. 1) Order 2022 and shall come into operation on 28th Day of January 2023.

Part II

2. Amendments

The undernoted amendments have made to the following order:

The County Council of Durham (Spennymoor) (Prohibition of Waiting & Stopping, Restriction of Waiting, Loading/Unloading & Parking Places) Order 2011

Purpose of Amendments

The following brief synopsis of amendments should be viewed in conjunction with the plans identified within the schedules to the order, however the plan(s) shall prevail in the event of any discrepancy:

To introduce 'No waiting At any time' restrictions:

- a. on the northern side of the junction from the C152, King Street into High Grange
 Road for 4 metres extending west from existing 'no waiting at any time' restrictions
 and ending at existing school keep clear markings Plan DV108 Refers.
- b. on the southern side of the junction from the C152, King Street into High Grange
 Road for 6 metres extending east from existing school keep clear markings Plan
 DV108 Refers.
- c. on the northern side of the junction from Holborn/Oxford Road into the Aldi access road for 8.5 metres extending west from existing 'no waiting at any time restrictions – Plan DV107 Refers.
- d. on the southern side of the junction from Holborn/Oxford Road into the Aldi access road for 2.5 metres extending west from existing 'no waiting at any time restrictions – Plan DV107 & DV108 Refers

- e. on the western side of Festival Walk extending south from existing 'no waiting at any time' restrictions for 79 metres from a point adjacent to No. 27 Cheapside Plan DV107 Refers.
- f. on the eastern side of Festival Walk extending south from existing 'no waiting at any time' restrictions for 70 metres from a point adjacent to No. 27 Cheapside Plan DV107 Refers.
- g. around the southernmost point of Festival Walk for 20m from a point adjacent to No.
 1 High Street ending at a point adjacent to No. 1 Cheapside Plan DV107 Refers.
- h. on the eastern side of Front Street, starting from the boundary between Jewson and
 Unit 3 Front Street for a distance of 10.5 metres in a southern direction. Plan
 DW106 Refers
- i. on the western side of Front Street, starting from a point 5m south of the boundary between Jewson and Unit 3 Front Street, for a distance of 36.5 metres. – Plan DW106 Refers

3. Schedules

Plans DV107 and DV108 have been amended to reflect the changes to those restrictions noted in Article 2 above and new plan bearing reference number DW106 has been inserted. Where these plans are referenced in the Schedules to the Order described in Article 2 above, new plans bearing the seal date as at the date of this Amendment Order have been inserted.

Part III

4. Saving

In so for as any provision of this Order conflicts with any provision which is contained in an Order made or having effect as if made under the Act or by or under any other enactment then the provisions of this Order shall prevail.

The prohibitions and restrictions imposed by this Order shall be in addition to and not derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act or by or under any other enactment.
