# THE COUNTY COUNCIL OF DURHAM (FERRYHILL) (PROHIBITION AND RESTRICTION OF WAITING, LOADING, STOPPING & PARKING PLACES ORDER) ORDER 2011 (AMENDMENT No. 1) ORDER 2018

The County Council of Durham ("the Council") in exercise of their powers under Sections 1, 2, 4, 32 and 35 & Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended ("the Act") and Part 6 of the Traffic Management Act 2004, as amended and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

#### Part I

### 1. General

This Order may be cited as The County Council of Durham (Ferryhill) (Prohibition and Restriction of Waiting, Loading, Stopping & Parking Places) Order 2011 (Amendment No. 1) Order 2018 and shall come into operation on 20th December 2018

# Purpose of Amendments

Amends Ferryhill 43

The following brief synopsis of amendments should be viewed in conjunction with the plans identified within the Schedules to the above Order, however the plans should prevail in the event of any discrepancy:

- Saddler Street/Durham Road (Plan EA103)
  - o Introduce No Waiting At Any Time on north side of Saddler Street commencing from a point adj No 7 easterly to the centre line of its junction with Durham Road (approx. 12 metres) then easterly on Durham Road (east side) for approx. 65 metres.
- Market Street (Plan EB103):
  - Remove the existing No Stopping 6pm-6am except taxis / parking 6am-6pm 1 hour no return within 1 hour restrictions adjacent to Nos 16-20 and introduce No Stopping Except taxis
  - Remove the existing Parking 8am-6pm 1 hour no return within 1 hour restriction adj to Nos 21-22 and introduce No Stopping except taxis
  - Remove the existing Parking Mon-Sat 8am-6pm 1 hour no return within 1 hour restriction adj to Nos 25-26

- B6287 Darlington Road (Plan EA102):
  - Remove the existing Parking 1 hour no return within 1 hour restriction and introduce:
    - Parking Mon-Sat 8am-6pm 1 hour no return within 1 hour adj properties 4-6 on east side of the road; and
    - Loading only 8am-6pm adj properties 7-8 on east side of the road
