# THE COUNTY COUNCIL OF DURHAM (DURHAM CITY) (ON STREET PARKING PLACES – TARIFFS & PERMITS) ORDER 2014 (AMENDMENT NO. 2) ORDER 2017

The County Council of Durham ("the Council") in exercise of their powers under Sections 1, 2, 4, 32 & 35 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended ("the Act") and Part 6 of the Traffic Management Act 2004, as amended and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

#### General

This Order may be cited as The County Council of Durham (Durham City) (On Street Parking Places – Tariffs & Permits) Order 2014 (Amendment No. 2) Order 2017 and shall come into operation on the 10<sup>th</sup> day of November 2017.

The amendments have been made to the following Order:

#### **Purpose of Amendments**

The following brief synopsis of amendments should be viewed in conjunction with the plans identified within the Schedules to the above Order, which are located within The County Council of Durham (Durham City North East) (Parking & Waiting Restrictions) Consolidation Order 2015 and which should prevail in the event of any discrepancy:

Introduce a new Car Club Permit Holders Only Parking Place on Elvet Waterside.

## ARTICLE 2 - Interpretation

A new definition has been included which reads:

"Car Club" means a shared use vehicle available for hire by Car Club members and being used within an organised scheme operated by or on behalf of a provider authorised by the Council".

Article 5 - Table 3 referencing Durham City, North East has been amended as follows:

Column A – Parking: Permit Holders Only Mon-Sat 8am-6pm now refers to Schedules 10(a) & 11

A new Restriction has been inserted which reads:

Parking: Car Club Permit Holders Only	10(b)	4
