

# THE COUNTY COUNCIL OF DURHAM (FRAMWELLGATE MOOR, PITY ME, NEWTON HALL AND BRASSIDE) (TRAFFIC MANAGEMENT) ORDER 2011 (AMENDMENT NO. 1) ORDER 2015

The County Council of Durham ("the Council") in exercise of their powers under Sections 1, 2, 4, 32 & 35 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended ("the Act") and Part 6 of the Traffic Management Act 2004, as amended and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

#### General

This Order may be cited as The County Council of Durham (Framwellgate Moor, Pity Me, Newton Hall and Brasside) (Traffic Management) Order 2011 (Amendment No. 1) Order 2015 and shall come into operation on the 5<sup>th</sup> day of October 2015.

#### **Amendments**

The under-noted amendments have been made to the following Order:

## **Purpose of Amendments**

The following brief synopsis of amendments should be viewed in conjunction with the plans identified within the Schedules to the above Order, however the plan(s) should prevail in the event of any discrepancy:

- To introduce No Waiting At Any Time on both sides of Abbey Road from Smithfield Road eastwards to the roundabout, except for an area of parking 9am-3pm, 3 hours no return before 6pm, on the north side 35 metres east of its centreline with Smithfield for 10 metres. Plan DX150 refers.
- 2. To extend the No Waiting, No Loading At Any Time on the east side of Smithfield Road northwards for 25 metres. Plan DX150 refers.
- 3. To replace the existing parking bays with No Waiting at Any Time. Plan DX144 refers.

- Schedule 3: (a) the title of this schedule has been amended to read: "Parking Places".

- 2. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act or by or under any other enactment.
