The following brief synopsis of amendments should be viewed in conjunction with the plans identified within the Schedules to the above Order, however the plan(s) should prevail in the event of any discrepancy:
(1) C17 Woodland Road, Bearpark - remove the existing No Stopping Mon-Fri 8am6 pm on entrance markings from, opposite Cook Avenue.
(2) C18a Whitehouse Lane, Ushaw Moor - Introduce 30 minute limited waiting MonSat 9am-5pm 4 mins no return within 3 hours outside of the pharmacy
(3) C18a Whitehouse Lane, Ushaw Moor - introduce no waiting at any time on the east side of Whitehouse Lane from its junction with Victoria Court to Hall Ave, Ushaw
Moor; and
(4) C18a Whitehouse Lane, Ushaw Moor - introduce no waiting at any time on the west side of from its junction with Welby Drive in both directions for approx. 20 m .
