THE COUNTY COUNCIL OF DURHAM (LAN CHESTER AND LANGLEY PARK) (PROHIBITION AND RESTRICTION OF WAITING AND LOADING) ORDER 2010 (AMENDMENT NO. 2) ORDER 2016

The County Council of Durham ("the Council") in exercise of their powers under Sections 1, 2, 4, 32 & 35 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended ("the Act") and Part 6 of the Traffic Management Act 2004, as amended and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

1. General

This Order may be cited as The County Council of Durham (Lanchester and Langley Park) (Prohibition & Restriction of Waiting and Prohibition of Loading) Order 2010 (Amendment No. 2) Order 2016 and shall come into operation on the 6th day of March 2017.

2. Amendments

The under-noted amendments have been made to the following Order:

Purpose of Amendments

The following brief synopsis of amendments should be viewed in conjunction with the plans identified within the Schedules to the above Order, however the plans should prevail in the event of any discrepancy:

(i) To a length of 'no waiting at any time' on junction of Quebec Street and South View between property no's 28 & 29 (both sides) and extending On west side for the full gable length of property no. 29. (Pian DL148 refers)

(ii) To introduce a length of 'no waiting at any time' on junction of Front Street leading down rear of Front Street between property no's 36 & 37 extending on north side to between No.s 32 & 33 and south side for the full length of gable of property No. 37. (Plan DM148 refers)

(iii) To introduce a length of 'no waiting at any time' from the entrance to Annfield House on Front Street to its junction with May Terrace extending on south side to its junction with rear of May Terrace. (Plan DL147 refers)

(iv) To replace a length of 'no waiting or loading at any time' with 'no waiting at any time' around corner of 1 Quebec Street onto Front Street. (Plan DL148 refers)
