

**THE COUNTY COUNCIL OF DURHAM
(DURHAM CITY (NORTH WEST))
(PARKING AND WAITING RESTRICTIONS) ORDER 2012
(AMENDMENT NO. 1) ORDER 2018**

The County Council of Durham ("the Council") in exercise of their powers under Sections 1, 2, 4, 32 & 35 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended ("the Act") and Part 6 of the Traffic Management Act 2004, as amended and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

General

1. This Order may be cited as The County Council of Durham (Durham City North West) (Parking & Waiting Restrictions) Order 2012 (Amendment No. 1) Order 2018 and shall come into operation on the 30th day of April 2018.

Amendments

2. The under-noted amendments have been made to the following Order:

The County Council of Durham (Durham City North West) (Parking & Waiting Restrictions) Order 2013.

Purpose of Amendments

3. The following brief synopsis of amendments should be viewed in conjunction with the plans identified within the Schedules to the above Order, however the plan(s) should prevail in the event of any discrepancy:
 - Introduce Permit Holder Only Parking Mon-Sat 8am-6pm (Zone TB) in The Bowers (Plan ref DW140 refers). This restriction also extends into The Durham City (South West) (Parking & Waiting Restrictions) Order 2013

Plans DW140 referred to in Article 3 above will replace existing Plan contained in the Order described in Article 2 bearing a seal date as at the date of this Amendment Order.

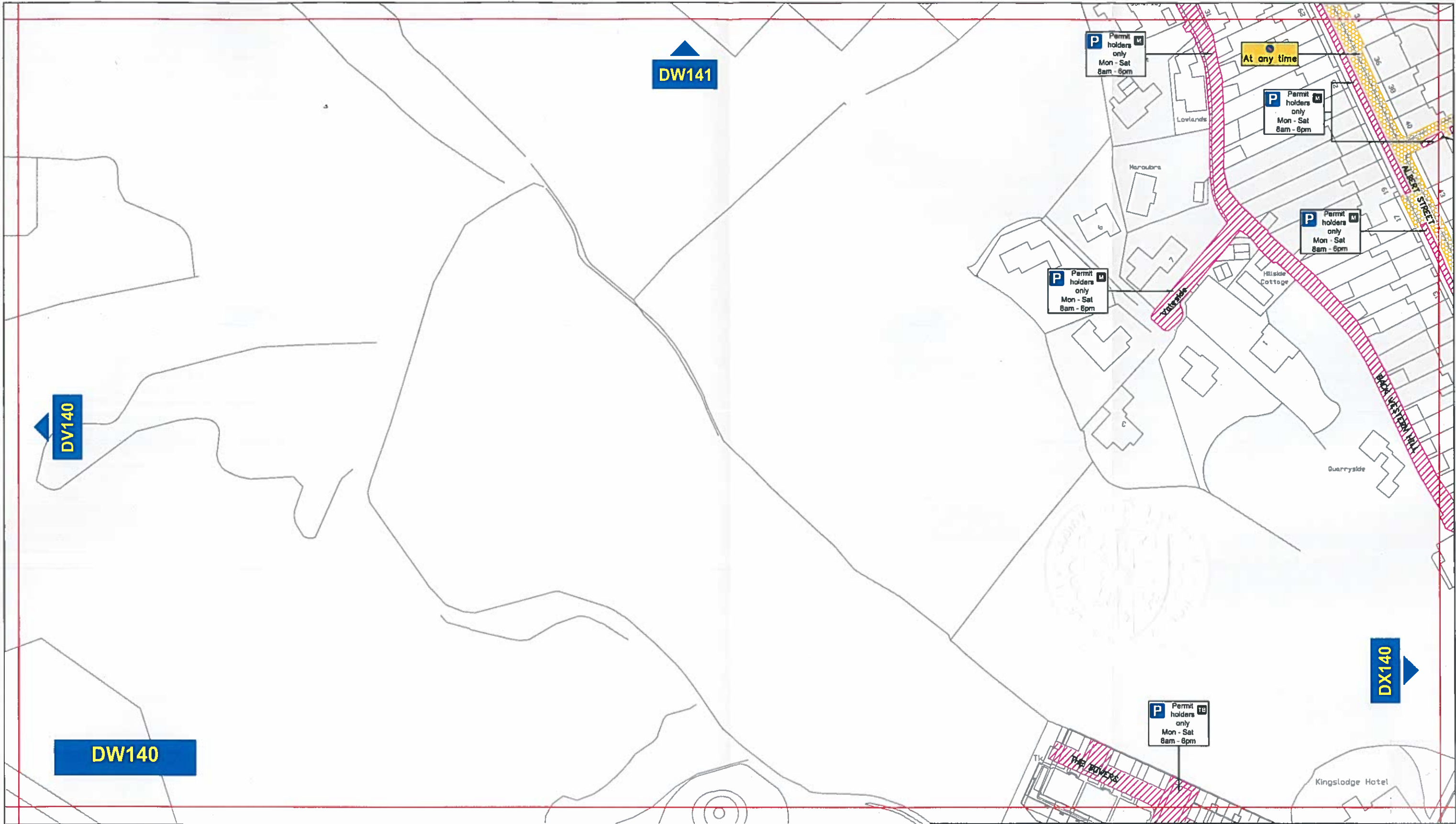
Saving

4. Insofar as any provision of this Order conflicts with any provision which is contained in an Order made or having effect as if made under the Act or by or under any other enactment then the provisions of this Order shall prevail.
5. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act or by or under any other enactment.
