Part I

This Order may be cited as The County Council of Durham (Peterlee and Horden) (Prohibition and Restriction of Waiting and Prohibition of Loading/Unloading) Order 2010 (Amendment No. 1) Order 2015 and shall come into operation on the 6th day of July 2015.

Purpose of Amendments

The following brief synopsis of amendments should be viewed in conjunction with the plans identified within the Schedules to the above Order, however the plans should prevail in the event of any discrepancy:

Introduce Prohibition of Waiting At Any Time on the following:

- (A) Judson Road east side for its full length, west side from its junction with the substation northwards for its full length. Plans EX134, EX135 & EY134 refer.
- (B) Shotton Road north side around its junction with Judson Road. Plans EX133, EX134, EY133 & EY134 refer.
- (C) Grampian Drive -- south side extending from the existing No Waiting/No Loading/Unloading At Any Time restriction westwards for 127m, north side, 46m west of the existing No Waiting/No Loading/Unloading At Any Time restriction eastwards for a length of 27m. Plan FA131 refers.
- (D) Pennine Drive east side from its junction with Mendip Close to its junction with the access into Howletch Lane Primary School, west side with its access into the School northwards for a length of 53m. Plan EZ132 refers.
