The County Council of Durham ("the Council") in exercise of their powers under Sections 1, 2, 4, 32, 35, 45 & 47 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended ("the Act") and Part 6 of the Traffic Management Act 2004, as amended and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

General

 This Order may be cited as The County Council of Durham (Durham City North East) (Parking & Waiting Restrictions) Consolidation No. 1 Order 2014 (Amendment No. 2) Order 2015 and shall come into operation on the 1st day of July 2015.

Amendments

2. The under-noted amendments have been made to the following Order:

The County Council of Durham (Durham City North East) (Parking & Waiting Restrictions) Consolidation No. 1 Order 2014.

Purpose of Amendments

The following brief synopsis of amendments should be viewed in conjunction with the plans identified within the Schedules to the above Order, however the plan(s) should prevail in the event of any discrepancy:

- Freemans Place move the existing bus only bay southwards by 7 metres into the new 35m layby. Plan Dy139 refers.
- Freemans Place relocate the existing loading bay from the east side to the west side of the road into the new 30 metre layby some 85 metres north of the bridge. Plan DY140 refers.
- Freemans Place introduce a loading bay on the west side approx. 3 metres north
 of the access into Freemans Quay north for a distance of 15 metres. Plan DY140
 refers.
- Freemans Place introduce Parking 20 mins no return within 1 hour into the new 15 metre layby situated some 5 metres south of the access into Freemans Quay. Play DY140 refers.

ARTICLES

Article 2 (Definitions)

The following amendments have been made to the definitions:

"pedestrian zone" – reference to Article 8 and Schedule 3 have been removed and reference to Article 9 and Schedule 4 inserted.

"resident" - reference to Schedule 10 has been included;

A new Article 33 has been inserted which reads;

Parking: 20 mins No return within 1 hour

- 33. (1) The areas of highway identified within the individual plans detailed in Schedule 17 to this Order are hereby authorised to be used as parking places, subject to the provisions of this Order, for the parking of motor vehicles only on such days and during such hours as identified within those individual plan(s).
 - (2) Save as provided in Article 42 of this Order no person shall cause or permit any vehicle, other than a vehicle loading or unloading goods, to wait in a loading bay on such days and during such hours as identified within the individual plan(s) detailed in Schedule 17 to this Order.
 - (3) The limits of each loading bay shall be indicated, by the Council, on the carriageway by the appropriate traffic signs.
 - (4) Every vehicle using a loading bay shall so stand so that every part of the vehicle is wholly within the loading bay AND in those cases where special provision is made is identified within the individual plan(s) detailed in Schedule 17 to this Order, in accordance with those provisions.

Articles 34 to 44 inclusive - these articles have been renumbered as 35 - 45 inclusive.

Article 42 (renumbered): sub Articles (1) and (2) – reference to Article 34 has been inserted. Sub Articles (3) and (6) reference to Article 33 has been inserted.
