THE COUNTY COUNCIL OF DURHAM (BISHOP AUCKLAND) (PARKING AND WAITING RESTRICTIONS) (CONSOLIDATION NO. 1) ORDER 2014 (AMENDMENT NO. 1) ORDER 2015

The County Council of Durham ("the Council") in exercise of their powers under Sections 1, 2, 4, 32 and 35 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended ("the Act"); Part 6 of the Traffic Management Act 2004, as amended, and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

Part I

General

This Order may be cited as The County Council of Durham (Bishop Auckland)
 (Parking and Waiting Restrictions) (Consolidation No. 1) Order 2014 (Amendment No. 1) Order 2015 and shall come into operation on the 1st day of February 2016.

Part II

Amendments

The following amendments apply to:

Purpose of Amendments

The following brief synopsis of amendments should be viewed in conjunction with the plans identified within the Schedules to the above Order, however the plans should prevail in the event of any discrepancy:

- (a) Cockton Hill Road Introduce restricted Parking Mon-Sat 8am-6pm Max Stay 1 hour No Return within 2 Hours on the west side of the road adjacent to property No's 38-48; (plan ref: DL88 refers)
- (b) Escomb Road remove approx. 55m of Permit Holder Only restricted parking (north side from gable of No. 29 westwards and south side from gable of No 20 westwards to a point where both meet existing No Waiting No Loading at Any Time restriction; (plan ref: DL89 refers)
- (c) Newgate Street remove 14m of No Waiting At Any Time and replace with Loading Only between No.s 213 and 215; (plan ref: DL90 refers)
- (d) Adelaide Street remove 11m of No Waiting At Any Time and replace with restricted Parking Mon-Sat 8am-6pm max stay 1 hour no return within 2 hours, adjacent property No's 1-3; (plan ref: DL91 refers)
- (e) Westfield Road introduce 15m of double yellow lines (No Waiting At Any Time) at the junction with Northumberland Avenue; (plan ref: DK88 refers)
- (f) <u>James Street</u> introduce 11m of restricted Parking Mon-Sat 8am-6pm max stay 30 mins on the north side of the road adjacent to No. 59 Cockton Hill Road; (plan ref: DL88 refers):
- (g) Acacia Road introduce 14m of double yellow lines (No Waiting At Any Time) on each corner at the junction with Beech Road (plan ref: DL89 refers);
- (h) Oak Terrace introduce 14m of double yellow lines (No Waiting At Any Time) on each corner at the junction with Beech Road; (plan DL89 refers);

- (i) High Bondgate introduce Permit Holder Only Parking Mon-Sat 10am-11am and 2p m-3 m from pr operty No. 8 to No. 34 (plan ref. DK93/DL9 3 refer);
- Finkle Street introduce 4.5m 6 N oWaiting and No Loa ding At AnyTime & th e entrance to the small private car park adjacent to No. 32; (p lan DL93 refes);
- (k) Fore Bondate introduce restricted Parking Mon-Sat 8am -noon say 1 hour in the layby that runs between property No.s 40 £55; (plan DL 93 refers);
