

**THE COUNTY COUNCIL OF DURHAM  
(PELTON, PERKINSVILLE AND OUSTON)  
(PARKING & WAITING RESTRICTIONS)  
(CONSOLIDATION NO. 1) ORDER 2014 (AMENDMENT No. 1) ORDER 2018**

The County Council of Durham ("the Council") in exercise of their powers under Sections 1, 2 & 4 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended ("the Act") and Part 6 of the Traffic Management Act 2004, as amended and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

**Part I**

**General**

1. This Order may be cited as The County Council of Durham (Pelton, Perkinville and Ouston) (Parking & Waiting Restrictions) (Consolidation No. 1) Order 2014 (Amendment No 1) Order 2018 and shall come into operation on the 1<sup>st</sup> day of August 2018

**Part II**

**Revocation**

2. The following Order has been revoked in part and its effects transferred to this Order:  
  
The County Council of Durham (Various Schools, North Durham – Derwentside, Chester-le-Street and Easington Areas) (No Stopping on School Entrance Markings) Order n2009 – Schedule 2, Item 11, Parts 1 & 2 (St Benet's RC Primary School)

**Purpose of Amendments**

3. The following brief synopsis of amendments should be viewed in conjunction with the plans identified within the Schedules to the above Order, however the plan(s) should prevail in the event of any discrepancy:
  - **C5 Ouston Lane** – Introduce No Waiting at any time on the north west side from the most southern access to Unc. Ouston Lane northwards to a point approx. 26 metres north east of St. Benet's Way.
  - **St Benet's RC Primary School, St Benet's Way, Pelton** – No Stopping Mon-Fri 8am-6pm on entrance markings (effects transferred as outlined in Article 2 above):
    - **North/west/south west side of road** – from a point 23.2 metres east of the centre line of access road to St. Benet's RC Primary School in an easterly then northern then north westerly direction for a distance of 43.56 metres.
    - **North/east/south east side of road** – from a point 29.7 metres east of the centre line of the access road into St. Benet's Primary School in a north westerly then northern then north easterly direction for 43.56 metres.

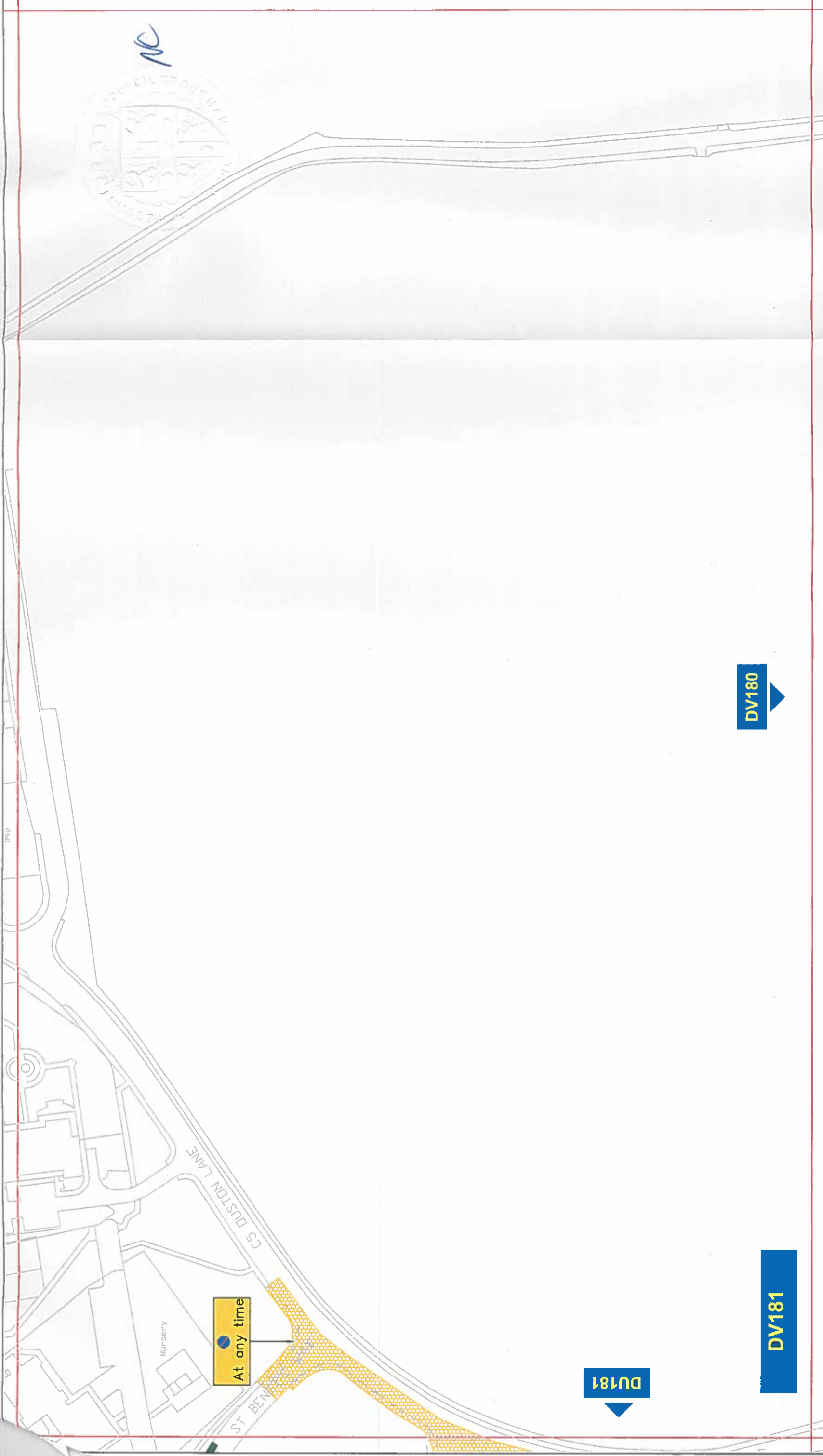
