

# THE COUNTY COUNCIL OF DURHAM (DURHAM CITY (SOUTH WEST)) (PARKING AND WAITING RESTRICTIONS) ORDER 2013 (AMENDMENT NO. 1) ORDER 2017

The County Council of Durham ("the Council") in exercise of their powers under Sections 11, 2, 4, 32, 35, 45, 46, 46A, 47 & 49 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended ("the Act") and Part 6 of the Traffic Management Act 2004, as amended and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

### General

 This Order may be cited as The County Council of Durham (Durham City South West) (Parking & Waiting Restrictions) Order 2013 (Amendment No. 1) Order 2017 and shall come into operation on the 8th day of May 2017.

# **Purpose of Amendments**

3. The following brief synopsis of amendments should be viewed in conjunction with the plans identified within the Schedules to the above Order, however the plan(s) should prevail in the event of any discrepancy:

To introduce No Stopping 10am-6am except taxis & Loading Only 6am-10am restrictions in two purpose built laybys on North Road:

- (1) on the south side of North Road running from its junction with Neville Street in a south easterly direction for approximately 40 metres; and
- (2) on the north side of North Road running in a south easterly direction from No. 75 North Road for approximately 35 metres.

### **ARTICLES**

Amendments have been made to the following Articles:

Article 10 - the title has been amended to read "Prohibition of Loading"

### Article 11 - has been amended to read:

- (a) No Stopping on Entrance Markings
- (b) No Stopping 10am-6am except taxis
- 11. Save as provided in Article 38 of this Order no person shall, except upon the direction or with the permission of an enforcement officer cause or permit any vehicle other than those vehicles specifically authorised by this Order, to stop or wait on the lengths of roads or sides of lengths of roads on such days and during such times as identified in the individual plan(s) detailed in Schedules 5 (a) and (b) to this Order.
