The County Council of Durham ("the Council") in exercise of their powers under Sections 1, 2, 4, 32 and 35 to the Road Traffic Regulation Act 1984, as amended ("the Act") and Part 6 of the Traffic Management Act 2004, as amended and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

Part I

1. General

This Order may be cited as The County Council of Durham (Peterlee and Horden) (Prohibition and Restriction of Waiting and Prohibition of Loading/Unloading) Order 2010 (Amendment No. 1) Order 2018 and shall come into operation on the 15th day of October 2018.

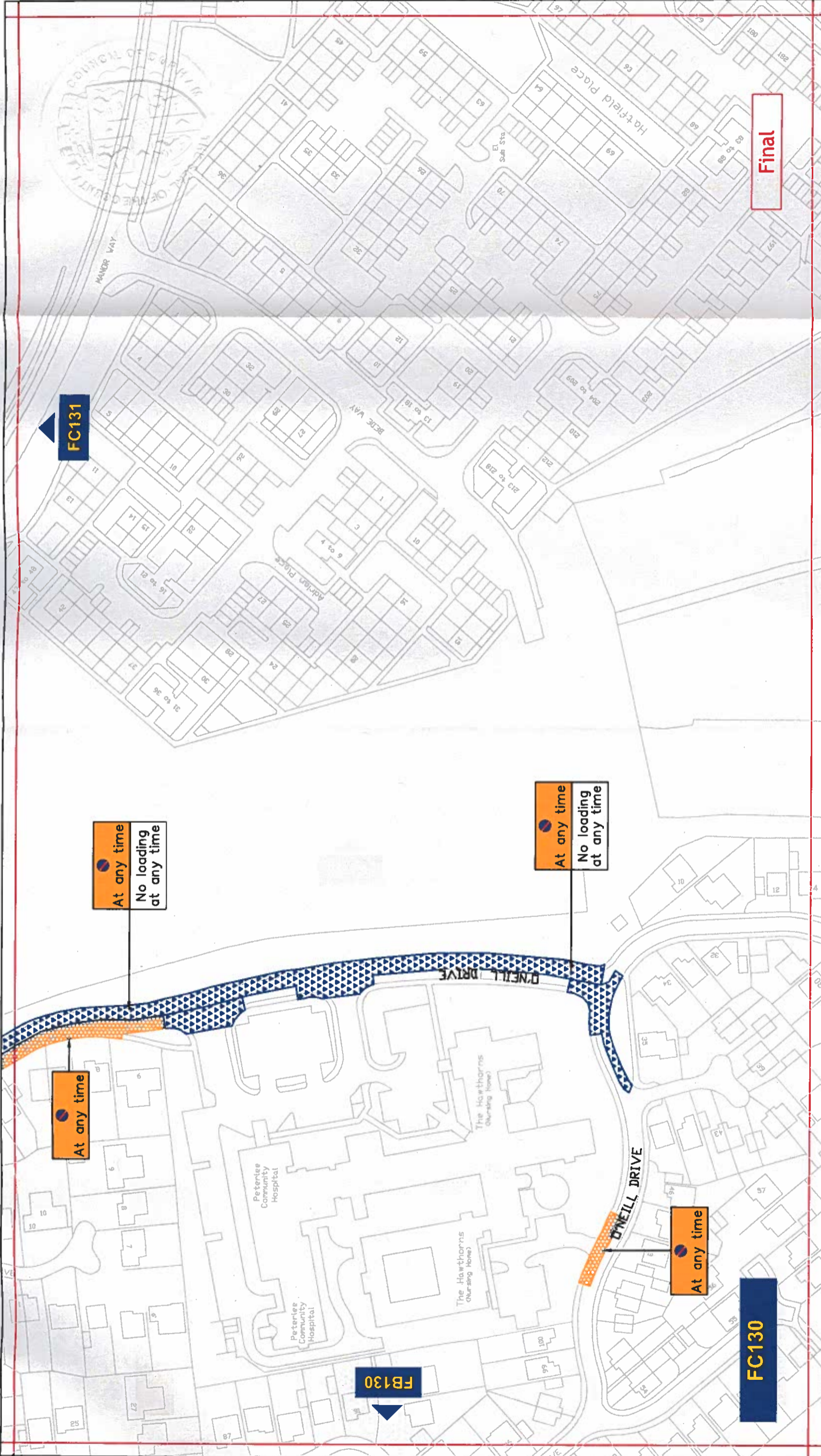

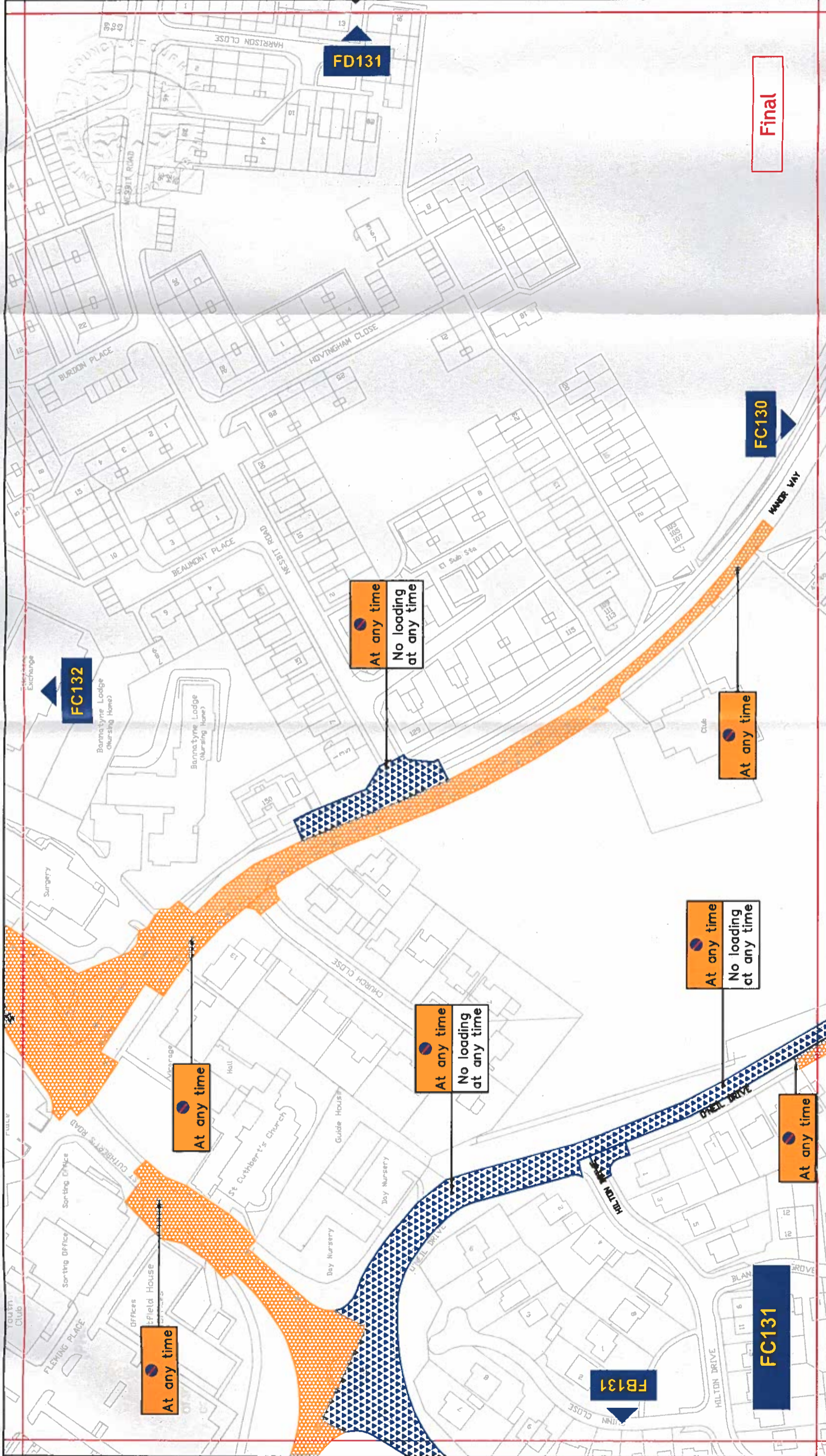
