THE COUNTY COUNCIL OF DURHAM (DURHAM CITY SOUTH EAST) (TRAFFIC MANAGEMENT) ORDER 2008

The County Council of Durham ("the Council") in exercise of their powers under Sections 1, 2, 4, 32, 35 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended, ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

Part I

General

1) This Order may be cited as The County Council of Durham (Durham City South East) (Traffic Management Order) 2008 and shall come into operation on 12 September 2008.

Interpretation

- 2) In this Order the following expressions have the meanings hereby respectively assigned to them:-
 - "Buses" have the same meaning as in Regulation 22 of the Traffic Signs Regulations 2002;
 - "Police Vehicle" means a vehicle marked with high visibility livery and permanent, fixed emergency warning lights that are clearly visible;
 - "pedal cycle" means a unicycle, bicycle, tricycle, or cycle having four or more wheels, not being in any case mechanically propelled unless it is an electrically assisted pedal cycle of such class as is to be treated as not being a motor vehicle for the purposes of the 1984 Act
 - "Universal service provider" has the same meaning as in the Postal Services Act 2000:
 - "Taxi" has the same meaning as "hackney Carriage" as defined in S 80(1) of the Local Government (miscellaneous Provisions) Act 1996:
 - "Enforcement Officer" means a uniformed police officer, police community support officer or any subsequent designation of these officers:
 - "Disabled person's badge" has the same meaning as in the Disabled Person's (Badge's for Motor Vehicles) (England) Regulations 2000 (as amended):
 - "Parking disc" means a device which:

- is 125 millimetres square coloured blue, if issued on or after 1
 April 2000, or orange if issued before that date
- (b) has been issued by a local authority and has not ceased to be valid and
- (c) is capable of showing the quarter hour during which a period of waiting began;

Part II

Revocation

- 3) The Orders detailed in Schedule 1 of this Order are hereby revoked in part.
- 3a) The Orders detailed in Schedule 2 of this Order are hereby revoked in full.

Part III

Prohibition of waiting at any time

4) Save as provided in Article 12 of this Order no person shall, except upon the direction or with the permission of an enforcement officer, cause or permit any vehicle to wait on any of the lengths of roads or sides of lengths of roads specified in Schedule 3 to this Order.

Prohibition of waiting between the hours of 8am and 6pm

5) Save as provided in Article 12 of this Order no person shall, except upon the direction or with the permission of an enforcement officer, cause or permit any vehicle to wait between the hours of 8am and 6pm on any of the lengths of roads, or sides of lengths of roads specified in Schedule 4 to this Order.

Prohibition of Loading/Unloading at any time

6) Save as provided in Article 12 of this Order, no person shall except upon the direction or with the permission of an enforcement officer, cause or permit any vehicle to wait on any of the lengths of roads or sides of lengths of roads specified in Schedule 5 of this Order for the purposes of enabling goods to be loaded onto or unloaded from the vehicle.

Loading/Unloading only between the hours of 8am and 6pm Monday to Saturday

7) Save as provided in Article 12 of this Order no person shall, except upon the direction or with the permission of an enforcement officer, cause or permit any vehicle to wait between the hours of 8am and 6pm Monday to Saturday on any of the lengths of roads, or sides of lengths of roads specified in Schedule 6 to this Order other than for the purpose of loading or unloading goods onto or from the vehicle.

Disabled parking only Limited to 3 hours

8) Save as provided in Article 12 of this Order no person shall, except upon the direction or with the permission of an enforcement officer, cause or permit any vehicle to wait on any of the lengths of roads, or sides of lengths of roads specified in Schedule 7 to this Order unless they display in the relevant position a disabled persons badge and parking disk (on which the driver or other person in charge of the vehicle, has marked the quarter hour period during which the period of waiting began) for a period not exceeding 3 hours.

No Stopping except Police vehicles

9) Save as provided in Article 12 of this Order no person shall, except upon the direction or with the permission of an enforcement officer, cause or permit any vehicle to stop or wait on any of the lengths of roads, or sides of lengths of roads specified in Schedule 8 to this Order other than a police vehicle.

Prohibition of waiting except Buses

10) Save as provided in Article 12 of this Order no person shall, except upon the direction or with the permission of an enforcement officer, cause or permit any vehicle to wait on any of the lengths of roads, or sides of lengths of roads specified in Schedule 9 to this Order other than a bus.

Pedal cycle parking only

11) Save as provided in Article 12 of this Order no person shall, except upon the direction or with the permission of an enforcement officer, cause or permit any vehicle to wait on any of the lengths of roads, or sides of lengths of roads specified in Schedule 10 to this Order other than a pedal cycle.

Part IV

Exceptions

12) (1) Nothing in Articles 4, 5, 6, 7, 8, 9, 10, or 11 of this Order shall render it unlawful to cause or permit any vehicle to wait or stop in the lengths of roads or sides of lengths of roads referred to therein for so long as may be necessary to enable:-

the vehicle. if it cannot conveniently be used for such purpose in any other road, to be used in connection with any of the following operations namely –

(i) building or demolition:

- (ii) the removal of any obstruction to traffic;
- (iii) the maintenance, improvement or reconstruction of the said roads:
- (iv) the laying, erection, alteration or maintenance in or in land adjacent to the said lengths of roads of any sewer, main, pipe or apparatus for the supply of gas, water or electricity or any telecommunications apparatus as defined in the Telecommunications Act 1984:
- (a) the vehicle if it cannot conveniently be used for such purpose in any other road to be used in the service of a local authority or water authority in pursuance of statutory duties;
- (b) the vehicle to be used for the purpose of delivering or collecting postal packets in the service of a universal service provider.
- Nothing in Articles 4, 5, 6, 7, 8, 9, 10, or 11 of this Order shall apply to any vehicle being used for police, fire brigade or ambulance purposes.
- (3) Nothing in Articles 4, 5, 8, 10 or 11 of this Order shall render it unlawful to cause or permit a vehicle which displays in the relevant position a disabled person's badge and parking disc (on which the driver or other person in charge of the vehicle, has marked the quarter hour period during which the period of waiting began) to wait in any of the lengths of road or the sides of road referred to in Schedules 3, 4, 7, 9 and 10 to this order for a period not exceeding three hours.
- (4) Nothing in Articles 4, 5, 6, 7, 8, 10, or 11 of this Order shall render it unlawful to cause or permit any vehicle to wait in the lengths of roads or sides of lengths of roads referred to in Schedules 3, 4, 5, 6, 7, 9, and 10 of this Order for so long as may be necessary to enable the picking up or setting down of passengers
- Nothing in Articles 4 and 5 of this Order shall apply to any official vehicle being used in connection with weddings or funerals.

Part V

Saving

- 13) In so far as any provision of this Order conflicts with any provision which is contained in an Order made or having effect as if made under the Act or by or under any other enactment then the provisions of THIS Order shall prevail.
- The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act or by or under any other enactment.
