

**THE COUNTY COUNCIL OF DURHAM
(DURHAM CITY)
(ON STREET PARKING PLACES - TARIFFS & PERMITS)
ORDER 2014**

The County Council of Durham ("the Council") in exercise of their powers under Sections 1, 2, 4, 32 & 35 & Pt IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended ("the Act"), Part 6 of the Traffic Management Act 2004 and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-

PART I

Citation & Commencement

1. This Order may be cited as The County Council of Durham (Durham City) (On Street Parking Places - Tariff & Permits) Order 2014 and shall come into operation on the 2nd day of February 2015.

Interpretation

2. In this Order the following expressions have the meanings hereby respectively assigned to them:-

"initial charge" means the charge referred to in in Column D of Schedule 1 to this Order with respect to the period of parking required.

"parking bay" and "parking place" means an area of highway designated as such under the provisions of this Order;

"parking meter" has the same meaning assigned to it by Section 46 (2) (a) of the Road Traffic Regulation Act 1984;

"permit" means a permit and a "valid permit" issued under the provisions of the relevant Order to which it relates;

"permit holder" means a person to whom a permit has been issued under the provisions of the Orders described in Article 6 below.

3. Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment. Unless the context otherwise requires words denoting the singular shall include the plural and vice versa and words denoting persons shall include either gender, bodies corporate, unincorporated associations and partnerships.
4. The Interpretation Act 1978 shall apply for the interpretation of this Order.

Part II

5. The Articles and plans relating to tariffs, waiting periods, initial charge period and permit holder streets & eligibility address information contained in the Schedules appended to this Order should therefore be read in conjunction with the latest versions of the following Parking & Waiting Restrictions Orders which may be amended from time to time, varied, modified or consolidated:

6. **The Schedules in the Orders identified in Column A above relating to tariffs, waiting periods, initial charge periods, permit holder streets & eligibility address information relating to (a) Parking: Mon-Sat 8am-6pm Permit Holders or Pay at machine – Display Ticket and (b) Parking: Permit Holders Only Mon-Sat 8am-6pm have been revoked and replaced with new schedules within this Order as set out in column B above.**
7. Any variations in tariff information provided in this Order will be in issued in accordance with Article 46A of the Road Traffic Regulation Act 1984, as amended.

PART III

Contravention and Enforcement

8. (1) If a vehicle is in contravention of a provision of this Order a penalty charge shall be payable.
- (2) In the case of a vehicle in respect of which a penalty charge is payable, a penalty charge notice may then be issued by a Civil Enforcement Officer in accordance with the requirements of Section 78 of the Traffic Management Act 2004, as amended.

PART IV

Saving

9. In so far as any provision of this Order conflicts with any provision which is contained in an Order made or having effect as if made under the Act or by or under any other enactment then the provisions of this Order shall prevail.

10. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act or by or under any other enactment.

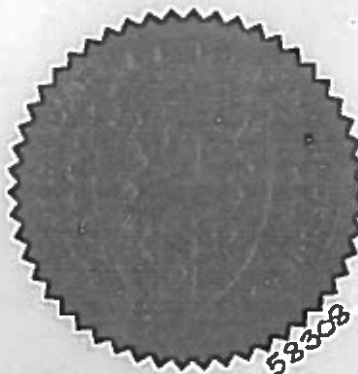

(AMENDMENT NO. 2) ORDER 2014**

The County Council of Durham ("the Council") in exercise of their powers under Sections 1, 2, 4, 32, 35, 45 & 46 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended ("the Act") and Part 6 of the Traffic Management Act 2004, as amended and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

Part I

General

1. This Order may be cited as The County Council of Durham (Durham City (South West)) (Parking and Waiting Restrictions) Order 2013 (Amendment No. 2) Order 2014 and shall come into operation on 2nd February 2015.

Purpose of Amendment

2. To remove all tariffs, waiting periods, initial charge periods, permit holder streets & eligibility address information contained in The County Council of Durham (Durham City (South West)) (Parking and Waiting Restrictions) Order 2013 and place this information in The County Council of Durham (Durham City) (On Street parking Places – Tariffs & permits) Order 2014.

Part II

Amendments

3. The following amendments apply to:

The County Council of Durham (Durham City (South West)) (Parking and Waiting Restrictions) Order 2013

ARTICLES

The following changes have been made to the under-noted Articles:

Article 2 (Interpretation)

The interpretation for "initial charge" has been amended to read:

"initial charge" means the charge referred to in Article 14 and detailed in The County Council of Durham (Durham City) (On-Street parking Places – Tariffs & permits) Order 2014 and any subsequent amendments, variations or consolidations of this Order with respect to the period of parking required.

Article 12

A new Article 12.(b) has been inserted which reads:

The tariffs, waiting periods, initial charge periods, permit holder streets & eligibility address information pertaining to this Article is displayed within The County Council of Durham (Durham City) (On Street Parking Places – Tariffs & Permits) Order 2014 and any subsequent amendment, variation or consolidation to this Order.

Article 13
