(AMENDMENT NO. 1) ORDER 2014**

The County Council of Durham ("the Council") in exercise of their powers under Sections 1, 2, 4, 32 and 35 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended ("the Act") and Part 6 of the Traffic Management Act 2004, as amended and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

General

- 1. This Order may be cited as The County Council of Durham (Shincliffe, High Shincliffe & Bowburn) (Parking & Waiting Restrictions) Order 2014 (Amendment No. 1) Order 2014 and shall come into operation on 9 February 2015.

Purpose of Amendments

The following brief synopsis of amendments should be viewed in conjunction with the plans identified within the Schedules to the above Order, however the plan(s) should prevail in the event of any discrepancy:

- a. Extend the existing **No Waiting At Any Time** restriction on the main access road into Bowburn North Industrial Estate, both sides, north eastwards for 12 metres. (Plan ref: EE123).
- b. Introduce a **No Waiting At Any Time** restriction on the Bowburn North Industrial Estate Road on the highway adjacent to Polar House. (Plan ref: EE123).

SCHEDULES

Plan reference EE123 [seal dated 20/3/14] has been removed and a plan of the same reference [seal dated as at the date of this Order] inserted into Schedule 1.

Saving

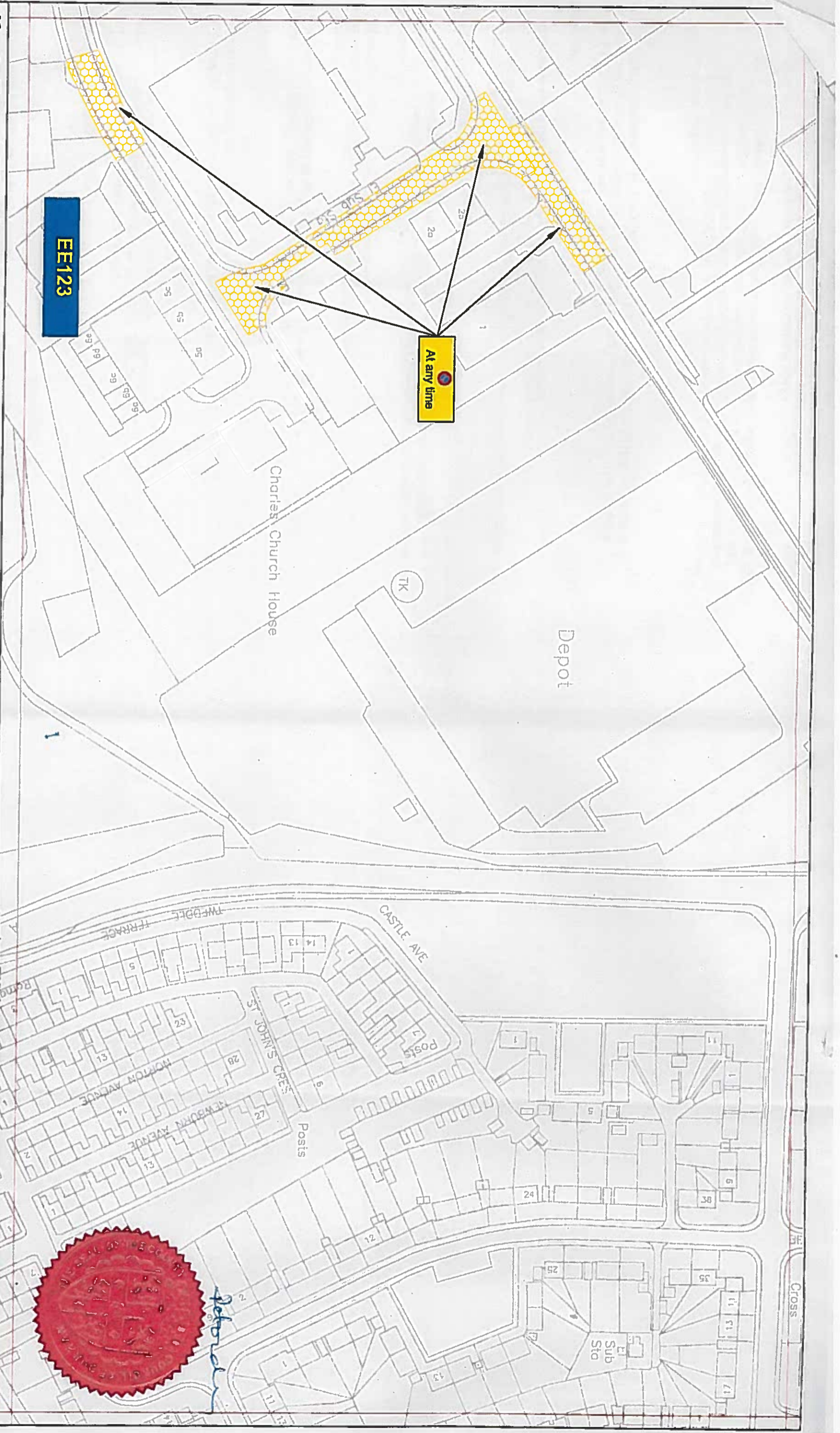
- 3. In so far as any provision of this Order conflicts with any provision which is contained in an Order made or having effect as if made under the Act or by or under any other enactment then the provisions of this Order shall prevail.
- 4. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act or by or under any other enactment.
