

THE COUNTY COUNCIL OF DURHAM (PETERLEE AND HORDEN) (PROHIBITION AND RESTRICTION OF WAITING AND PROHIBITION OF LOADING/UNLOADING) ORDER 2010 (AMENDMENT No. 1) ORDER 2014

The County Council of Durham ("the Council") in exercise of their powers under Sections 1, 2, 4, 32 and 35 to the Road Traffic Regulation Act 1984, as amended ("the Act") and Part 6 of the Traffic Management Act 2004, as amended and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

Part I

1. General

This Order may be cited as The County Council of Durham (Peterlee and Horden) (Prohibition and Restriction of Waiting and Prohibition of Loading/Unloading) Order 2010 (Amendment No. 1) Order 2014 and shall come into operation on 1st August 2014.

2. Revocation

The following order has been revoked in part and the effects transferred to this Order:

The County Council of Durham (Various Schools, North Durham – Derwentside, Chester-le-Street and Easington Areas) (No Stopping on School Entrance Markings) Order 2009 – Schoole 4: Yohden Primary School, Cotsford Primary School and Nursery Unit, Dene Community School of Technology and Dene House Primary School, Acre Rigg Infant and Junior School and Our Lady of the Rosary RC VA Primary School.

3. Amendments

b. Purpose of Amendments

The following brief synopsis of amendments should be viewed in conjunction with the plans identified within the Schedules to the above Order, however the plans should prevail in the event of any discrepancy:

- (A) reaffirm the existing No Stopping on entrance Markings Mon-Fri 8am-6pm at Our Lady of the Rosary RC Primary School on Westway, Acre Rigg Junior & Infant School on Acre Rigg Rd (plan ref: FA135), Dene House Primary School on Manor Way (plans ref: FD131 and FD132), Cotsford Infant & Yohden Primary Schools on Cotsford Lane (plans FF132 and FF133);
- (B) reduce the Restricted Waiting Mon-Fri 8am-6pm on Eden Lane (northerly end of restriction); at the junction of Keswick Road/Ellison Road and outside No's 25-27 Ellison Road (plan ref: FC134);

- (C) extend the following restrictions: No Waiting/No Loading At Any Time on St. Aiden's Way to include the back of the highway and the footpath (no physical changes to be made on site) (plans ref: FB130 & FB131); and No Waiting At Any Time on Whitehouse Way extend approx. 30m around the bend (plan ref: EY130); and (D) introduce No Stopping on entrance markings Mon-Fri 8am-6pm on Eden Lane (Seascape Primary School) (plan ref: FC134).
- (d) make minor administrative amendments to the Order to which the under-noted apply.

Articles
