

# THE COUNTY COUNCIL OF DURHAM (SEAHAM)

# (PROHIBITION AND RESTRICTION OF WAITING AND LOADING/UNLOADING & PARKING PLACES) ORDER 2010 (AMENDMENT NO. 1) ORDER 2015

The County Council of Durham ("the Council") in exercise of their powers under Sections 1, 2, 4, 32 & 35 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended ("the Act") and Part 6 of the Traffic Management Act 2004, as amended and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

#### General

 This Order may be cited as The County Council of Durham (Seaham) (Prohibition and Restriction of Waiting and Loading/Unloading & Parking Places) Order 2010 (Amendment No. 1) Order 2015 and shall come into operation on 1<sup>st</sup> April 2015.

### **Purpose of Amendments**

- (C) Introduce No Waiting/No Loading At Any Time on George Street. (Access road to George St. Ind. Est.). Plan FB163 refers.
