

**THE COUNTY COUNCIL OF DURHAM
(STANLEY, EAST STANLEY, SHIELD ROW & TANFIELD LEA)
(PROHIBITION AND RESTRICTION OF WAITING AND PROHIBITION OF
LOADING/UNLOADING) ORDER 2010 (AMENDMENT No. 1) ORDER 2015**

The County Council of Durham ("the Council") in exercise of their powers under Sections 1, 2, 4, 32 and 35 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended ("the Act") and Part 6 of the Traffic Management Act 2004, as amended and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

General

1. This Order may be cited as The County Council of Durham (Stanley, East Stanley, Shield Row & Tanfield Lea) (Prohibition & Restriction of Waiting and Prohibition of Loading/Unloading) Order 2010 (Amendment No. 1) Order 2015 and shall come into operation on the 9th day of March 2015.

Amendments

2. The under-noted amendments have been made to the following Order:

Purpose of Amendments

The following brief synopsis of amendments should be viewed in conjunction with the plans identified within the Schedules to the above Order, however the plan(s) should prevail in the event of any discrepancy:

1. Replace existing No Waiting At Any Time restriction with Parking Mon-Sat 8am-6pm 40 mins No return 1 hour on Thorneyholme Terrace South from the northern gable of No. 20 in a south westerly direction for approx. 30 metres.
2. Replace existing No Waiting At Any Time restriction with Loading Only Mon-Sat 8am-6pm on Thorneyholme Terrace South from the southern gable of No. 18 in a north easterly direction for approx. 35 metres.
3. Extend the existing No Waiting At Any Time restriction from the south east corner of the Health Centre on Thorneyholme Terrace South around the bound in a north easterly direction for approx. 25 metres.

4. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act or by or under any other enactment.
