## THE COUNTY COUNCIL OF DURHAM (OFF STREET PARKING PLACES) (DURHAM CITY PARK AND RIDE SITES) (AMENDMENT) ORDER 2007

The Durham County Council ("the Council") in exercise of their powers under Sections 32, 33, 34 and 35 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, as amended, ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-

## General

 This Order may be cited as The County Council of Durham (Off Street Parking Places) (Durham City Park and Ride Sites) (Amendment) Order 2007 and shall come into operation on the 26 February 2007.

## **Amendment**

- This Order hereby amends The County Council of Durham (Off Street Parking Places) (Durham City Park and Ride Sites) Order 2005 by:
- (i) Article 2 by the revocation of the definition for 'Fixed Charge' in its entirety and in its place insertion of the following:
  - "Fixed Charge' means the charge which will become payable should the vehicle be left within any of the Park and Ride Sites in contravention of any requirements of this Order;"
- (ii) Article 7 shall be revoked in its entirety and in its place insertion of the following:
  - 'All drivers and passengers using the Park and Ride Sites must do so with the intention of using and use the Park and Ride Bus Service.'
- (iii) Article 9 shall be amended by the addition of the following:
  - '(iv) motor car and caravan combinations less than 8.5 metres in total length which shall remain connected together while using the Park and Ride Sites.'
- (iv) By the addition of Article 12A as follows:
  - '12A No person shall cause or permit a vehicle to be left or wait or be parked in a Park and Ride Site outside of the Operational Hours as indicated in Article 22.'
- (v) By the addition of Article 19A as follows:

'Contravention of Article 19 will result in a Fixed Charge being issued as detailed in column 7 of the schedule.'

- (vi) Article 21 is hereby revoked in its entirety and in its place insertion of the following:
  - '21 When a vehicle is left in a parking place designated under Articles 3, 4 and 5 of this Order or waits in any other area in contravention of the provisions of Articles 6 to 16 inclusive and Article 19
  - a) a Fixed Charge shall be payable which shall be payable as described in Article 21B of this Order;
  - b) the Fixed Charge shall be levied in accordance with the procedures detailed in Article 24 of this Order.'
- (vii) By the addition of Article 21A
  - '21A The provisions of Article 21 shall also apply to any other equipment deposited within the Park and Ride Sites which in the opinion of a person authorised by the Council constitutes a contravention of this Order.'
- (viii) By the addition of Article 21B as follows:
  - '21B A Fixed Charge as detailed in Column 7 of the Schedule will become payable in the event of contravention of Articles 6 to 16 inclusive and Article 19.'
- (ix) The title to Article 28 shall be amended as follows:
  - 'Movement and Removal of Vehicles and Other Equipment'
- (x) By the addition of Article 28A as follows:
  - '28A The provisions of Article 28 shall apply equally to any other equipment deposited in the Park and Ride Sites which in the opinion of a person authorised by the Council constitutes a contravention of this Order and these provisions are extended to include for the disposal of the other equipment where it is deemed appropriate by the Council.'

## Saving

- 3. In so far as any provision of this order conflicts with any provision which is contained in an order made or having effect as if made under the Act or by or under any other enactment then the provisions of this order shall prevail.
- 4. The restrictions and prohibitions imposed by this order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act or by any other enactment.
