THE COUNTY COUNCIL OF DURHAM (BELMONT, CARRVILLE & GILESGATE) (PARKING & WAITING RESTRICTIONS) ORDER 2013 (AMENDMENT NO. 1) ORDER 2019

The County Council of Durham ("the Council") in exercise of their powers under Sections 1, 2, 4, 32 and 35 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended ("the Act") and Part 6 of the Traffic Management Act 2004, as amended, and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

Part I

General

 This Order may be cited as The County Council of Durham (Belmont, Carrville & Gilesgate) (Parking & Waiting Restrictions) Order 2013 (Amendment No. 1) Order 2019 and shall come into operation on the 18TH day of February 2019 .

Part II

2. Amendments

The following amendments apply to:

The County Council of Durham (Belmont, Carrville & Gilesgate) (Parking & Waiting Restrictions) Order 2013 and any subsequently amendments thereof.

Purpose of Amendments

The following brief synopsis of amendments should be viewed in conjunction with the plans identified within the Schedules to the above Order, however the plans should prevail in the event of any discrepancy:

1. High Street:

- a. East side from a point of 10 metres south of it junction with The Willows for distance of 3 metres in a southerly direction.
- b. East side from a point of 8 metres north of it junction with The Willows for distance of 9 metres in a northerly direction.
- c. East side from its junction with Grange Court in a northerly direction of 10 metres and in a southerly direction for 10 metres.
- d. West Side from its junction with the access road into Bristol Street Motors for a distance of 11 metres in a northerly direction and in a southerly direction for 3 metres.
- 2. **The Willows** from a point 11 metres east of its junction with High Street for a distance of 15 metres in a south easterly direction then in an north easterly direction for 13 metres into Taylor Court
- 3. **Grassdale** both sides from its junction with The Links in a northerly direction for 11 metres and in a southerly direction for 9 metres.
- 4. Belmont Industrial Estate Service Road (east side) from a point adjacent to Skoda Garage for 58 metres northerly to a point adjacent to Durham DTC.
- 5. Minor administrative amendments as required.
