The County Council of Durham ("the Council") in exercise of their powers under Sections 1, 2 and 4 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended ("the Act") and Part 6 of the Traffic Management Act 2004, as amended and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

General

 This Order may be cited as The County Council of Durham (Willington) (Prohibition and Restriction of Waiting, Loading, Stopping & Parking Places) Order 2011 (Amendment No. 1) Order 2019 and shall come into operation on the 18th July 2019

Purpose of Amendments

The following brief synopsis of amendments should be viewed in conjunction with the plans identified within the Schedules to the above Order, however the plan(s) should prevail in the event of any discrepancy:

- a. To introduce no waiting at any time on the east side of Cumberland Terrace from its junction with Commercial Street in a northerly direction for 11 metres
- b. To introduce no waiting at any time on the west Side of Cumberland Terrace from its junction with Commercial Street in a northerly direction for 25 metres
- c. To introduce no waiting at any time on East side of Cumberland Terrace from a point 57 metres north of its junction with Commercial Street in a northerly direction for 168 metres
- d. To introduce restricted waiting Monday Friday 8am 9am and 3pm 3pm on the west side of Cumberland Terrace from a point adjacent to the Southern boundary of the property 'Ennerdale' in a northerly direction for 17 metres
- e. To introduce restricted waiting Monday Friday 8am 9am and 3pm 4 pm west of Cumberland Terrace from a point adjacent to the southern boundary of the property 'The Conifers' in a northerly direction for 13 metres
- f. To introduce restricted waiting Monday Friday 8am 9am and 3pm 4pm on the west side of Chapel Street from a point adjacent to number 7a in a southerly direction for 30 metres

g. To introduce restricted waiting 9am – 6pm on both sides of Bridge End from its junction with the A690 in a southerly direction for 17 metres.
