THE COUNTY COUNCIL OF DURHAM (SEAHAM)

(PROHIBITION AND RESTRICTION OF WAITING AND LOADING/UNLOADING & PARKING PLACES) (AMENDMENT No. 2) ORDER 2012

The County Council of Durham ("the Council") in exercise of their powers under Sections 1, 2, 4, 32 and 35 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

Part 1

General

1. This Order may be cited as The County Council of Durham (Seaham) (Prohibition and Restriction of Waiting and Loading/Unloading & Parking Places) (Amendment No. 2) Order 2012 and shall come into operation on 25 June 2012.

Part II

Save as provided in Article 13 of this Order no person shall, except upon the direction or with the permission of an enforcement officer or civil enforcement officer, cause or permit any vehicle, other than that of a disabled badge holder, to wait on such days and during such hours, on any of the lengths of roads, or sides of lengths of roads identified within the individual plans detailed in Schedule 7 to this Order.

- iii) Article 11: This Article has been removed in its entirety.
- iv) Articles 12 and 13:
 - a. All references to loading bays within these Articles have been removed.
 - b. Reference to Article 11 has been removed
- v) Article 14:
 - a. Sub Articles (1), (2) and (5): reference to Article 11 has been removed.

- b. Sub Article (3) reference to Article 9 has been inserted.




Saving
