THE COUNTY COUNCIL OF DURHAM (BELMONT, CARRVILLE & GILESGATE) (PARKING & WAITING RESTRICTIONS) ORDER 2013 (AMENDMENT NO. 1) ORDER 2015

The County Council of Durham ("the Council") in exercise of their powers under Sections 1, 2, 4, 32 and 35 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended ("the Act") and Part 6 of the Traffic Management Act 2004, as amended, and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

Part I

General

 This Order may be cited as The County Council of Durham (Belmont, Carrville & Gilesgate) (Parking & Waiting Restrictions) Order 2013 (Amendment No. 1) Order 2015 and shall come into operation on 27 April 2015.

The County Council of Durham (Belmont, Carrville & Gilesgate) (Parking & Waiting Restrictions) Order 2013.

Purpose of Amendments

The following brief synopsis of amendments should be viewed in conjunction with the plans identified within the Schedules to the above Order, however the plans should prevail in the event of any discrepancy:

 Belmont Infants and Junior School and Belmont Comprehensive, Buckinghamshire Road. The existing restricted waiting has been amended from Monday – Friday 8–9am and 3-4pm, to Restricted Waiting to Monday of Friday, 8–9am and 2-4pm. (Plan EE142 refers)

ii) Broomside Lane / High Street junction, Belmont. It is proposed to introduce a length of 'No Waiting at Any Time' restriction at this location. (plan EE143 refers)

iii) Kinley Road, Carrville. It is proposed to introduce a "No Waiting at Any Time" restriction on (a) the north side of Kinley Road and (b) the south side around its junction with Filby Drive and around the corner of No 4 Kinley Road for a length of 20m. Filby Drive — north side from its junction with Kinley Road for a length of 22m, south side for a length of 19m (Plans EF145 £) EF146 refer).

iv) Belmont Business Park Road. It is proposed to introduce 'No Waiting At Any Time' restriction, north side, 10m east of its junction with Belmont Industrial Estate road for a length of 55m, covering the junction into Indigo House. (Plans EC143 & ED143 refer)

v) Make minor administrative amendments to the Order to which the under-noted apply.
