

The County Council of Durham (Coxhoe) (Parking and Waiting Restrictions) Order 2016 (Amendment No.1) Order 2021

The County Council of Durham ("the Council") in exercise of their powers under Sections 1, 2 & 4, and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended ("the Act") and Part 6 of the Traffic Management Act 2004, as amended and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

1.General

This Order may be cited as The County Council of Durham (Coxhoe) (Parking & Waiting Restrictions) Order 2016 (Amendment No. 1) Order 2021 and shall come into operation on the 5TH day of August 2021.

2.Amendments

The under-noted amendments have been made to the following Order:

The County Council of Durham (Coxhoe) (Parking & Waiting Restrictions) Order 2016

Purpose of Amendments

The following brief synopsis of amendments should be viewed in conjunction with the plans identified within the Schedules to the above Order, however the plan(s) should prevail in the event of any discrepancy:

To introduce no waiting at any time on:

- a. North side of Commercial Road East (Haul Road) from a point adjacent to Coxhoe Commercial Motors to and around the junction with Commercial Road East in a northerly direction for a total distance of 55 metres – Plans EH115 and EH116 refer.
- **b.** South side of Commercial Road East (Haul Road) from a point opposite Coxhoe Commercial Motors to and around the junction with Commercial Road East in a southerly direction for a total of 132 metres to a point opposite The Gem Café plans EH115 and EH116 refer.

To introduce restricted waiting on:

Commercial Road East, west side, from a point opposite the southerly end of the Bus Stop and Number 16/A Commercial Road East in a southerly direction for 10 metres to a point opposite Number 17/A Commercial Road East – Plan EH116 refers

3.Schedules

The following amendments to the Schedule(s) have been made:

Plans EH115 and EH116 have been amended to reflect the changes to those restrictions noted in Article 2 above. Where these plans are referenced in the Schedules to the Order described in Article 2 above, new plans bearing the seal date as at the date of this Amendment Order have been inserted.
