

**THE COUNTY COUNCIL OF DURHAM
(DURHAM CITY)
(ON STREET PARKING PLACES – TARIFFS & PERMITS) ORDER 2014
(AMENDMENT NO. 2) ORDER 2020**

The County Council of Durham (“the Council”) in exercise of their powers under Sections 1, 2, 4, 32 & 35 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended (“the Act”) and Part 6 of the Traffic Management Act 2004, as amended and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

1. General

This Order may be cited as The County Council of Durham (Durham City) (On Street Parking Places – Tariffs & Permits) Order 2014 (Amendment No. 1) Order 2020 and shall come into operation on the 5th day of April 2021.

2. Amendments

The amendments referred to below have been made to the following Order:

The County Council of Durham (Durham City) (On Street Parking Places – Tariffs & Permits) Order 2014.

Purpose of Amendments

The following brief synopsis of amendments should be viewed in conjunction with the plans identified within the Schedules to the above Order, which are located within the following Orders and which should prevail in the event of any discrepancy:

To Amend Permit Holders Only ‘B’ to No Waiting At Any Time restrictions on:
Hallgarth View from existing Double Yellow lines in a westerly direction around the turning head for 45 metres – plan DZ136 refers.

To Amend No Waiting At Any Time to Permit Holders ‘B’ or Pay at Machine Display Ticket on:
Whinney Hill, The Hallgarth Area in a layby for 24m – plan DZ137 refers.

3. Schedule


Plans DZ136 and DZ137 have been amended to reflect the changes to those restrictions noted in Article 2 above. Where these plans are referenced in the Schedules to the Order described in Article 2 above, new plans bearing the seal date as at the date of this Amendment Order have been inserted.

Saving

1. In so far as any provision of this Order conflicts with any provision which is contained in an Order made or having effect as if made under the Act or by or under any other enactment then the provisions of this Order shall prevail.

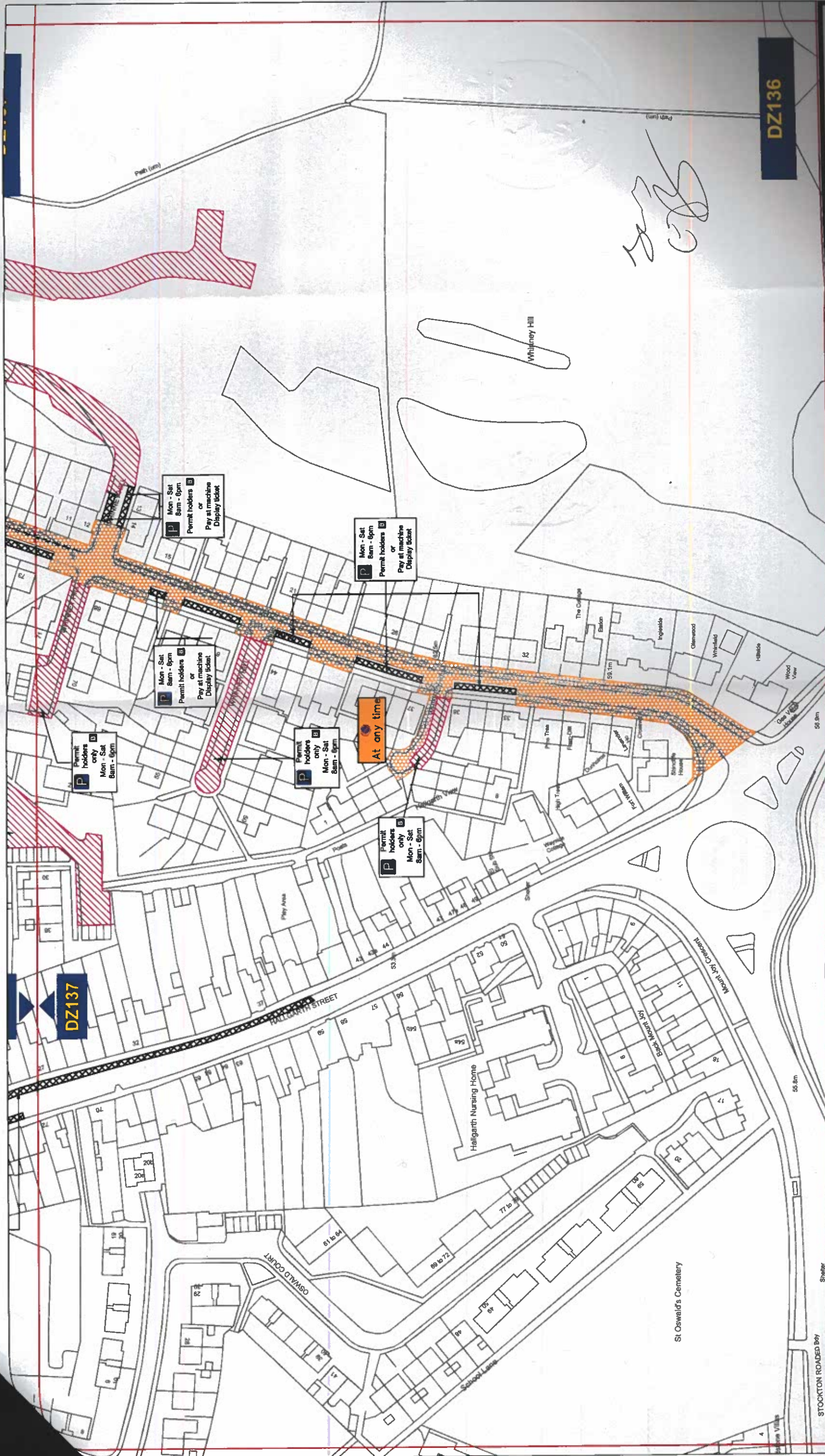

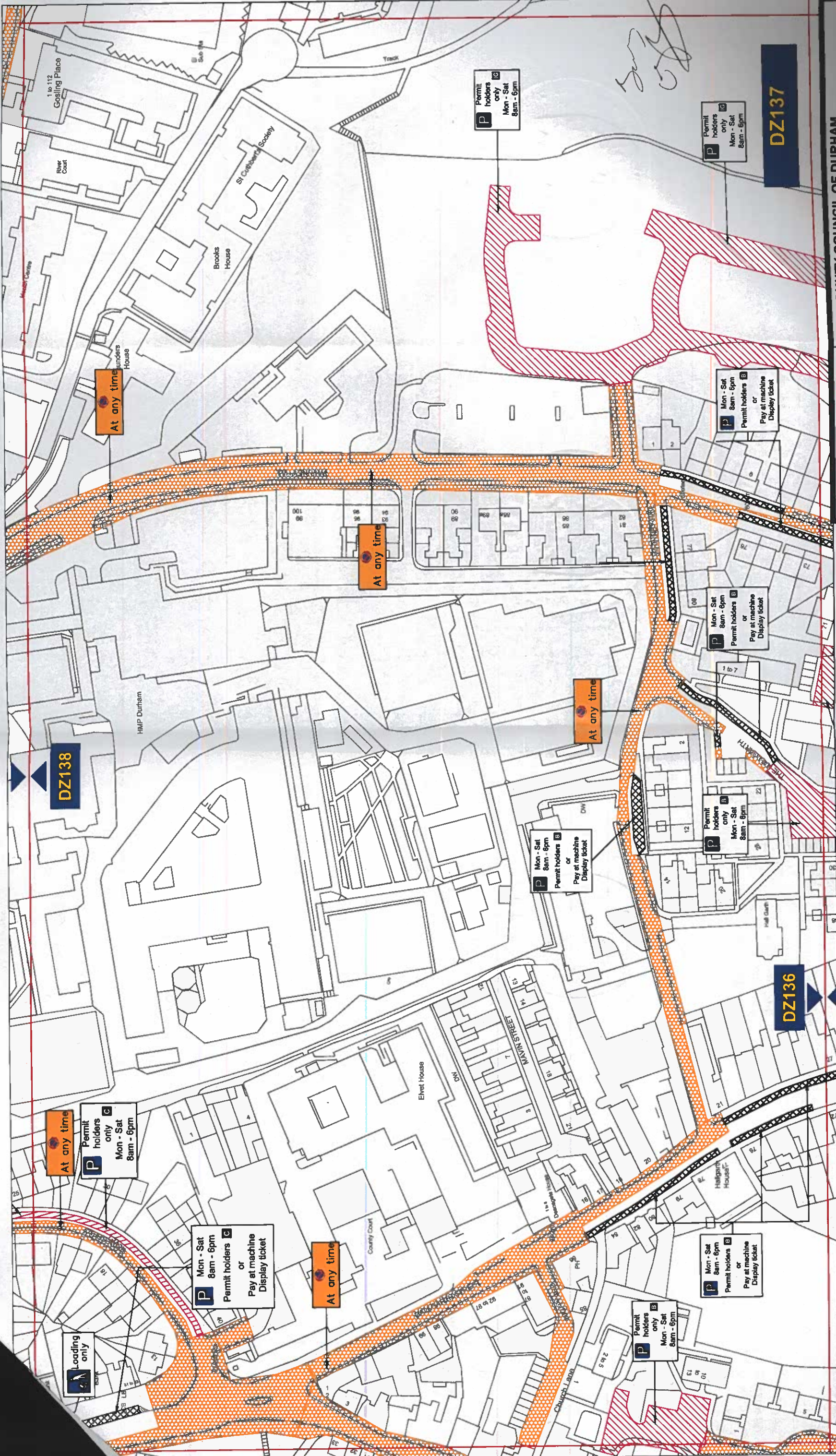
