

EAST DEVON DISTRICT COUNCIL (CIVIL ENFORCEMENT OFF-STREET PARKING PLACES)

AMENDMENT ORDER NO. 2 2014

The District Council of East Devon in the County of Devon (hereinafter called "the Council") in exercise of its powers under Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (as amended) as further regulated by the Local Authorities' Traffic Orders (Procedure) (England and Wales) Regulations 1996 (as amended) and of all other enabling powers, makes the following Order:-

COMMENCEMENT AND CITATION

1. This Order shall come into operation on the [*15th September*] 2014.
2. This Order may be cited as the "East Devon District Council (Civil Enforcement Off-Street Parking Places) Amendment Order No. 2 2014".
3. This Order shall be supplementary to the East Devon District Council (Civil Enforcement Off-Street Parking Places) Order 2008 (as amended) ("the 2008 Order").

VARIATION

The 2008 Order shall be varied as follows:

- (a) plan no. 26 to the 2008 Order and labelled "Harbour Road Car Park/SHORT STAY SEATON" and the entry associated with this parking place in the Schedule to the 2008 Order, shall be deemed removed from the 2008 Order;
- (b) plan no. 27 to the 2008 Order and labelled "Harbour Road Car Park/LONG STAY HARBOUR ROAD COACH PARK SEATON" shall be deemed removed from the 2008 Order; and
- (c) the plans attached to this Order and labelled:
 - i. Seaton Jurassic long stay car park, Seaton; and
 - ii. Seaton Jurassic Coach park, Seaton,

shall be substituted for the plan referred to in (b) above,

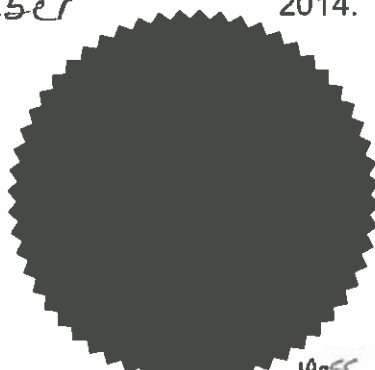
on the basis that, with effect from the date that this Order comes into operation, the parking place known as "Harbour Road Car Park/SHORT STAY SEATON" shall be deemed removed from the 2008 Order in its entirety, the parking place formerly known as "Harbour Road Car Park/LONG STAY SEATON" and now known as "Seaton Jurassic long stay car park, Seaton" shall be reduced in area and the location of the parking place formerly known as "HARBOUR ROAD COACH PARK SEATON" and now known as "Seaton Jurassic Coach Park, Seaton" shall be correctly documented.

SAVE AS AFORESAID the 2008 Order shall remain in full force and effect.

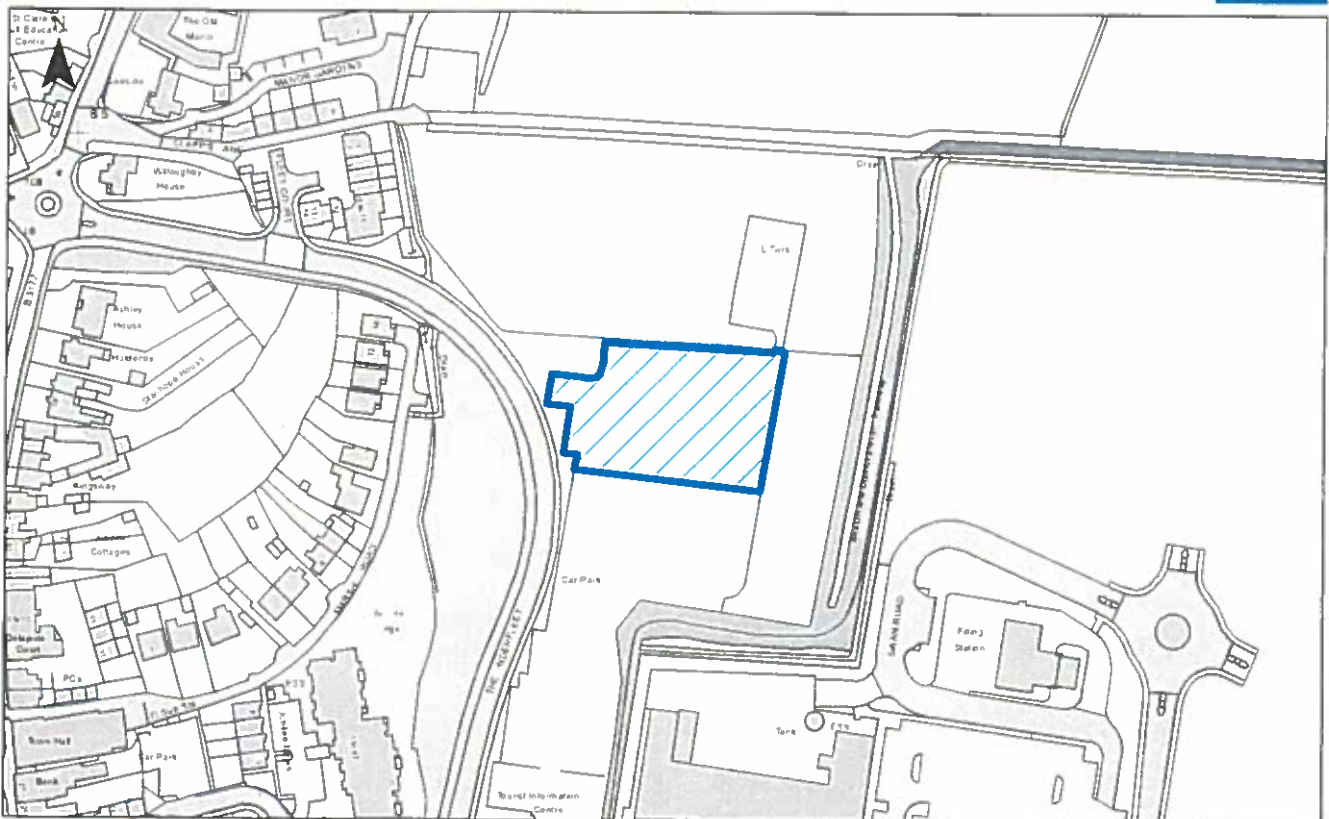

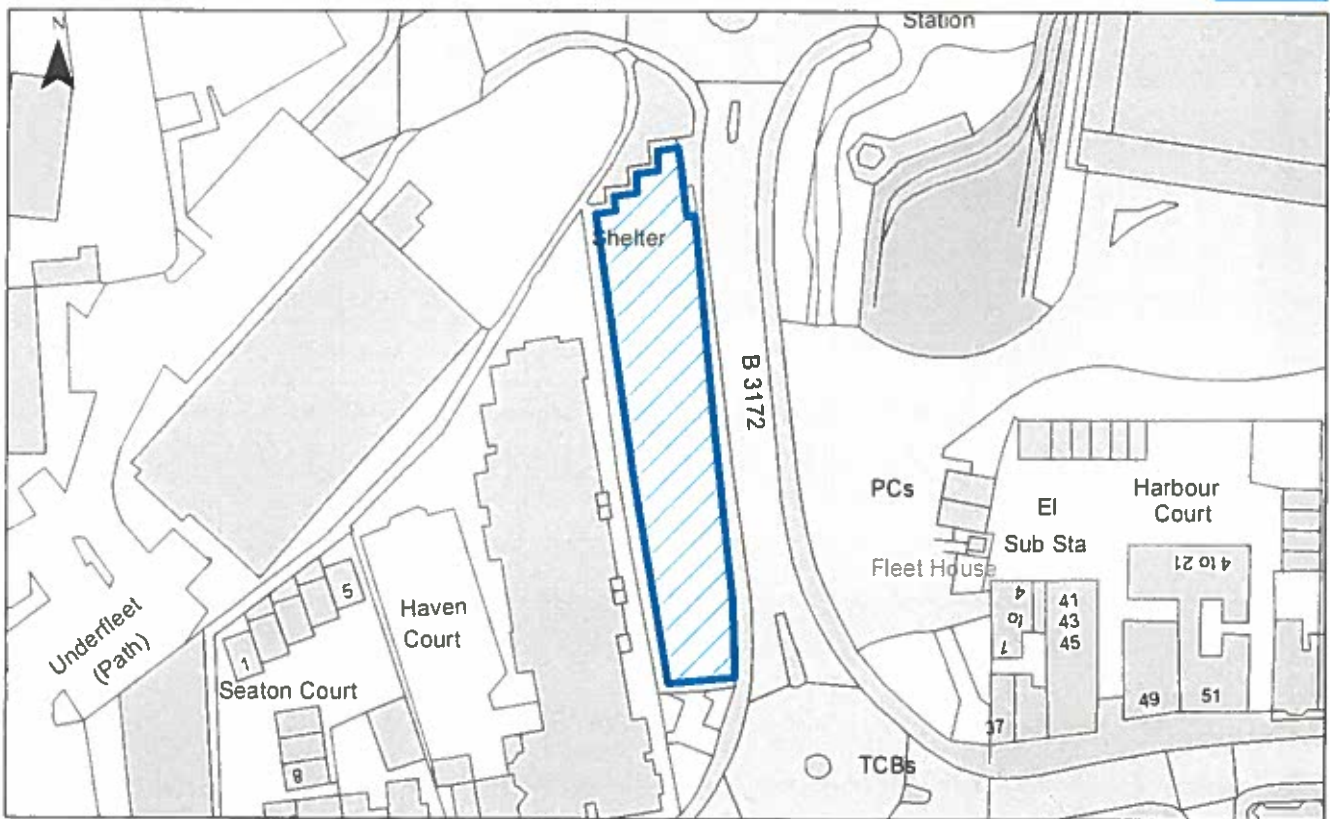
Seaton Jurassic long stay car park, Seaton
