# THE EAST HERTFORDSHIRE DISTRICT COUNCIL (CONTROL OF PARKING) (CONSOLIDATION) ORDER 2020

The Council of the District of East Herts (hereinafter referred to as "the Council") in accordance with Section 21 of The Local Authorities' Traffic Orders (Procedure) (England and Wales) Regulations 1996 and pursuant to arrangements made under Section 19 of the Local Government Act of 2000 and the Local Authorities (Arrangements for Discharge of Functions) (England) Regulations 2000 with Hertfordshire County Council ("the County Council") in exercise of the powers conferred by Sections 1(1) 2(1) – (3), 3, 4, 32 and 35, 45, 46, 47, 49,and 53 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the 1984 Act") (as amended by the Road Traffic Regulation (Parking) Act 1986) and Section 43 and Schedule 3 of the Road Traffic Act 1991 ("the 1991 Act") and the provisions of Part 6 of The Traffic Management Act 2004 ("the 2004 Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby make the following Order, the purpose of which is to incorporate all on street parking place and prohibition and restriction of waiting Orders into one Order.

#### **PARTI**

#### **GENERAL**

#### **Commencement Citation and Revocations**

- (1) This Order shall come into operation on 2 April 2020 and may be cited as "The "East Hertfordshire District Council (Control of Parking) (Consolidation) Order 2020" hereinafter referred to as "this Order".
  - (2) The East Hertfordshire District Council On-Street Parking and Waiting Plans ("the On-Street Plans") and the Schedules to this Order are incorporated into this Order.
- 2. This Order revokes, re-enacts and consolidates the restrictions imposed by the various Orders listed within Schedule 1 to this Order insofar as they relate to on-street parking places and prohibition and restriction of waiting within the District of East Hertfordshire.

#### Interpretation

- (1) Save as otherwise defined within this Order, each and every expression shall have the meaning assigned to it by the Traffic Signs Regulations and General Directions 2016 SI 362.
  - "Business Permit" means a Permit issued in accordance with Article 12 of this Order;
  - "Civil Enforcement Officer" has same meaning as in Section 76 (5) of the Act of 2004;
  - "Contractors Permit" means a Permit issued in accordance with Article 15 of this Order;
  - "Controlled Parking Zone (CPZ)" means either an area in which, except where parking places have been provided, every road has been marked with road markings and into which each entrance for vehicular traffic has been indicated by signs; or an area in which signs have been placed on each side of every road; and into which each entrance for vehicular traffic has been indicated by the signs;
  - "Council" means East Hertfordshire District Council and includes any parking services, contractors or authorised agent appointed by and acting on behalf of the Council for the purposes of any function under the provisions of this Order:
  - "Delivering" and "Collecting" means in relation to any goods include checking the goods for the purpose of their delivery or collection;
  - "Disabled Persons Badge", "Blue Badge" and "Parking Disc" have the same meaning as in the Local Authorities Traffic Orders (Exemption for Disabled Persons) (England) Regulations 2000;

"Disabled Persons Vehicle" means a vehicle displaying in the relevant position a disabled persons badge and which has been used immediately before or is about to be used by the person(s) in respect of whom the badge has been issued:

"Driver" means the person driving or having control or charge of the Vehicle at any given time and in particular in relation to a Vehicle waiting in a Parking Place the person driving at the time it was left in that Parking Place;

"Eligible Addresses" mean any postal addresses which are listed within Schedule 2 of this Order and therefore indicate that residents or entitled business user may apply for said permits;

"Entitled Business User" means a person who occupies premises the postal address of which is an eligible address as listed within Schedule 2 of this Order and which has no off-street parking space provided or authorised by any planning consent related to the premises and who is liable for payment of business rates on that premises:

"General Prohibition" means the prohibition as set out in Article 4 of this Order:

"Goods" means goods or burden of any description and includes postal packets of any description;

"Goods Vehicle" means a motor vehicle or trailer constructed or adapted for use for the carriage or haulage of goods or burden of any description;

"Heavy Commercial Vehicle" means any Goods Vehicle the gross laden weight of which exceeds 5 tonnes;

"Hours of Operation" means the hours specified in which a waiting restriction or Parking Zone applies;

"Household" means a dwelling with a separate entry on the Council's Tax register;

"Key" means the Key attached to the On-Street Plans to be read in conjunction with the On-Street Plans;

"Limited Waiting" means a vehicle may remain within a parking place so designated for the specified length of time during the hours of operation specified, but may stay no longer than this period of time:

"Local Service" has the same meaning assigned to it by Section 2 of the Transport Act 1985;

"Market day" means a day designated by the Council when a market may be held;

"Market stall" means a stall licensed by the Council utilised as part of a market;

"Market stall holder" means the named person in a market stall license issued by the Council;

"Market Trader" means a licensed person authorised to operate a market stall;

"Motor Car" has the same meaning as in Section 136 (2) of the 1984 Act;

"Motor Cycle" has the same meaning as in Section 136 (4) of the 1984 Act;

"Motor Vehicle" has the same meaning as in Section 136 (1) of the 1984 Act;

"No Return" means no return to a Parking Place within the same named road within a specified period;

"On-Street Plans" means the District of East Hertfordshire On-Street Parking and Waiting Plans including the Key and the Schedules, which are incorporated into this Order pursuant to Article 1(2) hereof:

"Operational Hours" means the hours within which the Residents' Parking Scheme or Pay and

Display Parking Places are operative as particularised in the Key to the On-Street Plans;

"Operational Vehicle" means a vehicle operated by the entitled business user for the purposes of making deliveries, collections, servicing or such other business purposes as the Council shall provide;

"Owner" has the same meaning as in Section 82 (2) and (3) of the 1991 Act;

"Paperless Parking Permit" or "Paperless Permit" means any Parking Permit issued electronically by the service provider;

"Paperless Parking Voucher" or "Paperless Voucher" means any Parking Voucher issued electronically by the service provider;

"Parking Attendant" has the same meaning as the term "Civil Enforcement Officer" as described in Section 76(5) of the 2004 Act;

"Parking Bay" means an area contained within a Parking Place delineated by white markings to indicate the position in which a Vehicle may be parked;

"Parking Disc" means a device which is 125 millimetres square and coloured blue has been issued by a local authority and has not ceased to be valid and is capable of showing the quarter hour period during which a period of waiting has begun as provided for in the Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (England) Regulations 2000 SI 683:

"Parking Permit" or "Permit" means a Resident Permit, Business Permit, Contractor Permit, Resident Visitor Permit and Special Parking Permit as applied for, issued and described under the provisions contained within this Order; or its paperless equivalent;

"Parking Place" means any place where a Vehicle, or Vehicles of any class, may wait as set out in Section 32 (4) (b) of the 1984 Act and as shown in the Key and On-Street Plans;

"Parking Voucher" or "Voucher" means a Visitor Voucher or Special Voucher issued by the Council under the provisions of this Order and bearing printed instructions for its validation on the front face; or its paperless equivalent:

"Passenger Vehicle" means a motor vehicle constructed solely for the carriage of passengers and their effects and adapted to carry not more than sixteen passengers exclusive of the Driver, and not drawing a trailer:

"Penalty Charge" shall have the meaning as a charge set by the Council in accordance with The Civil Enforcement of Parking Contraventions (Guidelines on Levels of Charges) (England) Order 2007 and the provisions of Part 6 and Schedule 9 the 2004 Act;

"Penalty Charge Notice" has the same meaning as in Section 66(1) of the 1991 Act;

"Permit Allowance" refers to the number of Business Permits, Resident Permits or Resident Visitor Permits which may be applied for by a resident of one household or a resident institution representative of the same institution or an entitled business user within a period of time as specified within this Order;

"Permit Holder" means a person to whom a Business Permit, Contractor Permit, Resident Permit, Resident Visitor Permits, Special Parking Permit or paperless equivalent, has been issued under the provisions of this Order:

"Permit Parking Place" means any place where Vehicles of the classes specified within this Order and display in the relevant position a valid Parking Permit, Parking Voucher or paperless equivalent, under the provisions of this Order may wait;

"Permit Parking Zone" or "PPZ" refers to all the Permit Parking Places in a specified area indicated by name or alphanumerical code which are to be used only by permit holders issued

Parking Permits for that specified area during the specified hours of operation as listed in the Schedules contained within the Orders Consolidated by this Order;

"Permitted Hours" means a period specified for each Permit Parking Place during which the waiting by vehicles of a specific class is permitted as specified on the On-Street Plans;

"Public Service Vehicle" has the same meaning as assigned to it by Section 1 of the Public Passenger Vehicles Act 1981;

"Relevant position" means on the dashboard or fascia of the vehicle or where the vehicle is not fitted with a dashboard or fascia in a conspicuous position on the nearside of the vehicle or if the vehicle is one being used by a disabled person displayed in such a position as described in the Disabled Persons (Badges for Motor Vehicles) (Amendment) Regulations 2000 SI 682 and in all cases displayed in such a position as to be clearly visible from outside the vehicle's front or nearside:

"Resident" means a person whose usual place of abode is at premises the postal address of which is an eligible address as contained within Schedule 2 of this Order;

"Resident Institution" means a land use, which, is neither a place of abode nor is it liable for payment of business rates, and where the postal address of the premises is an eligible address as listed in Schedule 2 of this Order;

"Resident Institution Representative" means a person acting on behalf of a resident institution, who has responsibility for the operation and maintenance of said institution;

"Resident Permit" means a Permit issued to a Resident or Resident Institution in accordance with Articles 10 or 11 of this Order;

"Resident Visitor Permit" means a permit issued in accordance with Articles 13 or 14 of this Order;

"Restricted Parking Zone" means an area which all the streets are subject to waiting restrictions other than lengths of road where parking bays are designated, whether these parking bays bear road markings or not;

"Road" means any length of highway or of any other road to which the public has access, and includes bridges over which a road passes as set out in Section 142 (1) of the 1984 Act;

"Service Provider" is a service administering parking transactions, records of Permits and Vouchers and records of Paperless Permits and Paperless Vouchers;

"Special Parking Permit" means a permit issued in accordance with Articles 16 or 17 of this Order:

"Street Trader" means a person consented by the Council to trade in the street;

"Traffic Sign" means a device or object as prescribed or authorised under, or having effect as though prescribed or authorised under section 64 of the 1984 Act;

"Universal Service Provider" and "Universal Postal Service" have the same meanings as that assigned to them in Section 4(3) of the Postal Services Act 2000;

"Vehicle" has the same meaning as that assigned to "motor vehicle" in Section 136(1) of the 1984 Act;

"Verge" means any part of a road not being a carriageway and includes road margins, central reservations and those areas laid for ornamental purposes maintained by East Hertfordshire District Council but does not include lay-bys;

"Visitor Voucher" means a voucher issued in accordance with Article 18 of this Order;

- (2) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.
- (3) The prohibitions, restrictions and requirements imposed by this Order shall be in addition to, and not in derogation of, any prohibition, restriction or requirement imposed by any regulation made or having effect as if made under the 1984 Act or by or under any other enactment.

#### **PART II**

# PROVISIONS APPLYING BOTH TO PARKING PLACES AND TO PROHIBITIONS AND RESTRICTIONS ON WAITING

#### General Prohibition on Stopping or Waiting of Vehicles

4. Save as provided in Article 7 of this Order no person shall, except upon the direction of or with the permission of a Police Constable in uniform, or with permission of a Civil Enforcement Officer as defined by the 2004 Act and appointed by East Hertfordshire District Council, cause or permit any vehicle to stop or wait on any part of a Road where stopping and waiting is prohibited or restricted as shown on the On Street Plans and indicated in the labels and Key to the On-Street Plans to this Order.

#### Restrictions on use of parking places

- 5. (1) Save as provided in Article 7 of this Order no person shall cause or permit any vehicle to stop or wait on areas of road or sides of the road as shown on the On-Street Plans and indicated in the key to those plans as parking places in contravention of the provisions imposed on those bays as identified and defined in the key to the On-Street Plans.
  - (2)Where a vehicle is parked in a parking bay within a parking place as shown on the On-Street Plans and identified and defined by the key to the On-street Plans the driver of that vehicle shall not permit the vehicle to wait in that parking bay unless it is wholly parked within the marked limits of the bay, whether those limits of the bay are indicated by road markings or contrasting surfacing.

#### Contravention of the General Prohibition or Restrictions

6. Where a person contravenes any provision of this Order, and the vehicle does not fall into any one of the exemptions contained within Article 7 of this Order, the owner of the vehicle in question shall incur a penalty charge as set by the Council in accordance with The Civil Enforcement of Parking Contraventions (Guidelines on Levels of Charges) (England) Order 2007 and the provisions of Part 6 and Schedule 9 the 2004 Act.

# **Exemptions to the General Prohibition and Parking Places**

- 7. The following Vehicles are exempt from the General Prohibition on Stopping and Waiting and Restrictions on use of parking places as set out in Articles 4, 5 and 8 of this Order:
  - (a) a Vehicle waiting for no longer than may be necessary and which is required for use in connection with any of the following namely:-
    - (i) the removal of any obstruction to traffic;
    - (ii) the laying, erection, alteration or repair in or near the Road, the side or length of the Road, of any sewer, main, pipe or apparatus for the supply of gas, water or electricity or of any telecommunications apparatus as defined in paragraph 1(1) of the Telecommunications Code contained in Schedule 2 to the Telecommunications Act 1984;
    - (iii) any building operation or demolition work provided that the Vehicle cannot conveniently be used in any other Road.

- (b) to enable a Vehicle in the service of the Council or any other local authority if it cannot conveniently be used for such purpose in any other Road, which is necessarily required for use in connection with:
  - (i) highway works, highways and parking enforcement, waste collection or street cleansing activities:
  - (ii) the maintenance, improvement or reconstruction on the areas of Road or sides of Road.
- (c) a Vehicle which is:
  - (i) required by law to stop; or
  - (ii) obliged to stop so as to prevent accident injury or damage to persons or property; or
  - (iii) prevented from proceeding by circumstances outside his control; or
  - (iv) caused or permitted to stop or wait upon the direction or with the permission of a police officer in uniform.
- (d) a Public Service Vehicle whilst waiting at an authorised stopping place;
- (e) a marked vehicle whilst being used by a Universal Service Provider in the course of the provision of a Universal Postal Service which is stationary only for so long as may be reasonably necessary for the delivery/collection of postal packets;
- (f) a Vehicle being used for fire brigade, ambulance or police purposes;
- (g) save as on the areas of Road or sides of the Road where loading or unloading are specifically regulated as identified and defined in the Key to the On-Street Plans, a Vehicle on which is displayed in the Relevant Position a valid Disabled Persons Badge and where applicable parking disc in the circumstances prescribed in regulations 7, 8 or 9 of the Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (England) Regulations 2000 SI 683;
- (h) a Vehicle that is waiting only for so long as is reasonably necessary to enable goods to be loaded on or unloaded from the Vehicle save on the areas of Road or sides of the Road where loading or unloading are specifically regulated as identified and defined as no stopping, waiting, loading or unloading in the Key to the On-Street Plans;
- (i) a Vehicle that is waiting only for so long as is necessary to enable a person to board or alight from that Vehicle, save for the areas of Road and sides of the Road as identified and defined as no stopping, waiting, loading or unloading in the Key to the On-Street Plans;
- (j) to enable the Vehicle to be used in connection with a valid street trading consent issued by the Council pursuant to Schedule 4 Local Government (Miscellaneous Provisions) Act 1982;
- (k) a vehicle which, whilst used by a Civil Enforcement Officer in the course of the enforcement of parking restrictions, is stationary only for so long as may be reasonably necessary for them to issue (or attempt to issue) a Penalty Charge Notice to a vehicle they believe to be parked in contravention of those restrictions or adjacent restrictions:
- (I) a market traders or street traders vehicle being used during designated market days which is required by the market stall holder for the setting up or breaking down of a market stall licensed by the council.

#### **PART III**

#### PROVISIONS APPLYING TO PERMITS AND PERMIT PARKING PLACES

# General Provision for Vehicles Stopping or Waiting in a Permit Parking Place

8. (a) Subject the provisions of this Order, Permit Parking Places may be used for the leaving during the permitted hours of vehicles of the following class, that is to say, passenger vehicles (the overall height of which does not exceed 2.3 metres and the overall length of which does not exceed 5.25 metres), goods carrying vehicles (the overall height of which does not exceed 2.3 metres and the overall length of which does not exceed 5.25

metres), motor cycles and disabled persons vehicles (on which must be displayed the relevant parking disc) that display a valid Parking Permit or Parking Voucher in the relevant position, or in respect of the use of that vehicle at that time a record of a Paperless Parking Permit or Paperless Parking Voucher is in effect.

- (b) Each area on a highway comprising the length of carriageway of a street specified within the Schedules contained within the Orders consolidated by this Order and shown on the On-Street Plans which unless otherwise so specified, is bounded on one side of that length by the edge of the carriageway and having a width throughout of at least 1.8 metres, as long as no obstruction of access is caused to any properties along the carriageway, is hereby designated as a Permit Parking Place.
- (c) Save as provided in Article 7 of this Order no motor vehicle may be parked in a Permit Parking Place during the specified hours without a valid Parking Permit, or valid Parking Voucher displayed in the relevant position, or in respect of the use of that vehicle at that time a record of a Paperless Parking Permit or Paperless Parking Voucher is in effect.
- (d) Where a motor vehicle is parked in contravention of Article 4 to this Order the driver of any such motor vehicle shall be issued with a penalty charge notice.
- (e) The absence of a Parking Permit or Parking Voucher, or a record of a Paperless Parking Permit or Paperless Parking Voucher, for a motor vehicle left in a Permit Parking Place shall be evidence of the fact that a Parking Permit or Parking Voucher has not been purchased by the driver of the vehicle.
- (f) Parking Permits and Parking Vouchers to be displayed on vehicles left in a Permit Parking Place at all times;
  - i) when a vehicle is left in a Permit Parking Place during the permitted hours, the driver thereof shall cause to be displayed in the relevant position a valid Parking Permit issued in respect of that vehicle or valid Parking Voucher so that all the particulars referred to in Articles 22 to 25 of this Order are readily visible from the front of the vehicle; or
  - ii) shall have purchased either a Paperless Parking Permit or Paperless Parking Voucher.
- 9. Where a Parking Permit has been displayed on a Vehicle in accordance with the provisions of this Order, no person, not being the driver of the vehicle shall remove the Parking Permit unless authorised to do so by the driver of the Vehicle.

#### **Eligibility for Parking Permits or Parking Vouchers**

- 10. Any resident of a Permit Parking Zone as identified in the Schedules contained within the Orders Consolidated by this Consolidation Order, who is the owner of a vehicle of a class specified in Article 8 may apply to the council for the issue of a **Resident Permit** relating to the PPZ within which they reside in respect of that vehicle, or vehicles at the discretion of the Council, and any such application shall be made on a form issued by and obtainable from the Council and shall include the particulars and information the form requires be supplied.
- 11. If a resident institution is the registered owner of a vehicle of the class specified in Article 8, the resident institution representative may apply to the Council on the institution's behalf for the issue of a **Resident Permit** relating to the PPZ within which they reside in respect of that vehicle and any such application shall be made on a form issued by and obtainable from the Council and shall include the particulars and information the form requires to be supplied.
- 12. Any entitled business user within a Permit Parking Zone as identified in the Schedules contained within the Orders Consolidated by this Consolidation Order, who is the owner of operational vehicles of the class specified in Article 8 may apply to the Council for the issue of a **Business Permit** relating to the PPZ within which their business premises are situated in respect of no more than two such operational vehicles and any such application shall be made on a form issued by and obtainable from the Council and shall include the particulars and information the form requires to be supplied.

- 13. Any resident or resident institution representative may apply to the Council for the issue of **Resident Visitor Permits** for Vehicles of the class referred to in Article 8 and any such application shall be made on a form issued by and obtainable from the Council and shall include particulars and information as the form requires to be supplied.
- 14. Any Council or other Authority service that, in the fulfilment of their statutory or welfare duties, must send Council staff to visit residents or resident institutions within a PPZ, may apply to the Council for the issue of **Resident Visitor Permits** up to a total number of hours as is documented to be necessary for the fulfilment of their duties within the hours of operation. Such application shall be made on a form issued by and obtainable from the Council and shall include particulars and information as the form requires to be supplied.
- 15. Any resident of resident institution representative may apply to the Council for the issue of a **Contractor Permit** for Vehicles of the class referred to in Article 8 where the vehicle is necessary to any building maintenance or other structural work taking longer then one week.
- 16. Any person (or any person acting on behalf of a resident or resident institution) may at any time apply to the council for the issue of a **Special Parking Permit** in respect of a vehicle of the class specified in Article 8 identifying the user of the vehicle. The decision to issue a special parking permit is at the discretion of the Council. Without prejudice to the generality of the Council discretion the following circumstances may be relevant to an application:
  - (a) the applicant's exceptional medical needs;
  - (b) the applicant's exceptional social needs;
  - (c) any exceptional difficulty experienced by a carer for any resident;
  - (d) the applicant's exceptional employment situation which requires that the applicant's vehicle be parked of necessity for business purposes near the applicant's home.
- 17. Any agency, professional practice or organisation which manages local doctors, midwives, district nurses, health visitors and various other essential domiciliary medical personnel may apply for the issue of a **Special Parking Permit** for the use of these personnel when visiting households in the PPZ and driving a vehicle of the class specified in Article 8. Where possible, such permits will be issued to a particular vehicle. The decision to issue a special parking permit and whether it will be issued to a vehicle, to an individual or to an agency, professional practice or organisation will be at the discretion of the Council.
- 18. Any resident may apply to the Council for the issue of **Visitor Vouchers**, up to the maximum annual allocation per household of the number of hours specified by the Council.

#### **Issue of permits**

- 19. (1) The Council may at any time require an applicant for a Permit or a Permit Holder to produce to an officer of the Council or authorised agent such evidence in respect of an application for a Permit made to them as they may reasonably call to verify any particulars or information given to them or in respect of any Permit issued by them as they may reasonably call for to verify that the Permit is valid;
  - (2) Upon receipt of an application duly made under the provisions of this Order and upon receipt of the charges specified in the Schedules contained within the Orders Consolidated by this Order for the Permit applied for, the Council upon being satisfied that the applicant meets the criteria specified in Articles 10 through 18 for the Permit for which they are applying, shall issue to the applicant the relevant Permit.
- 20. The Council shall not issue any Permit during a period of one year to a resident of any Household or a resident institution representative of the same resident institution or an entitled business user, in respect of which the allowance per Household Resident, Business and Resident Visitor Permits as set out in the Schedules contained within the Orders Consolidated by this Consolidation Order have been issued and remain valid during that period, subject to the provisions of Article 33.

21. A Contractor Permit or Special Parking Permit shall be issued subject to such terms and conditions as the Council shall think fit.

#### Form of Parking Permits and Parking Vouchers

- 22. A Resident or Business Permit shall include the following particulars;
  - (a) the registration mark of the vehicle or vehicles in respect of which the Permit has been issued unless at the discretion of the Council and due to circumstances reasonably verified by the Council, the Permit is issued without a particular registration mark;
  - (b) the period during which, subject to the provisions of Article 33, the Permit shall remain valid:
  - (c) an indication that the Permit has been issued by the Council; and
  - (d) an indication of the PPZ(s) within which the use of the Permit is valid.
- 23. A Resident Visitor Permit shall include the following particulars:
  - (a) the time of arrival, hours and minutes, the day of the week, the date in the month in which the Vehicle was first left in a Permit Parking Place;
  - (b) the date on which, subject to the provisions of Article 33, the Resident Visitor Permit becomes invalid; and
  - (c) an indication that the Permit has been issued by the Council.
- 24. A Contractor Permit or Special Parking Permit shall include the following particulars:
  - (a) the registration mark(s) of the vehicle(s) in respect of which the Permit is being issued where possible or at the Council's discretion, an indication of the individual or of the agency, professional practice or organisation to which the Permit has been issued;
  - (b) the period during which, subject to the provision of Article 33, the Permit shall remain valid:
  - (c) an indication that the Permit has been issued by the Council
  - (d) an indication of the PPZ (or other restricted parking areas) within which the special parking permit is valid.
- A Parking Voucher shall be in writing and shall include the following particulars:
  - (a) a serial number by which the Permit Holder may be identified;
  - (b) the day, date, month and year of commencement;
  - (c) the time of commencement on hourly Parking vouchers;
  - (d) an authentication that the Parking Voucher has been issued by the Council

#### **Validity of Parking Permits**

- a **Resident Permit** is valid for 12 months, for the leaving during the hours of operation in a Permit Parking Place of the vehicle to which such Resident Permit relates by the owner of such vehicle or by any person using such vehicle with the consent of the owner other than a person to whom such vehicle has been let for hire or reward.
- a **Business Permit** is valid for 12 months, for the leaving during the hours of operation in a Permit Parking Place of the Vehicle or either of the vehicles to which such Business Permit relates (but not both of them at the same time) by the owner of such vehicle or by any person using such vehicle with the consent of the owner other than a person to whom such vehicle has been let for hire or reward.
- a **Short Stay Resident Visitor Permit** shall authorise the leaving during the hours of operation in a Permit Parking Place of any Vehicle of a class specified in Article 8 for up to the number of hours indicated on the permit from the time and date indicated on the permit, and the charge shall be that specified in the Schedules contained within the Orders Consolidated by this Consolidation Order and the allowance of hours that is specified in the respective Schedules contained within the Orders Consolidated by this Consolidation Order.
- 29. a **One Day Resident Visitor Permit** shall authorise the leaving during the hours of operation in a Permit Parking Place of any Vehicle of a class specified in Article 8 from the time and

date indicated on the permit up to the end of the hours of operation on that date, and the charge shall be that specified in the Schedules contained within the Orders Consolidated by this Consolidation Order and each such Permit shall count as 10 hours of the allowance specified in the respective Schedules contained within the Orders Consolidated by this Consolidation Order.

- 30. a **One Week Resident Visitor Permit** shall authorise the leaving during the hours of operation in a Permit Parking Place of any Vehicle of a class specified in Article 8 for up to a maximum of 7 days from the time and date indicated on the Permit, and the charge shall be that specified in the Schedules contained within the Orders Consolidated by this Consolidation Order.
- a Contractor Permit shall be valid for such a period as the Council thinks fit but for no longer than a period of 3 months from the date the permit first becomes valid and shall authorise the leaving during the hours of operation in a Permit Parking Place a Vehicle of a class specified in Article 8.
- a **Special Parking Permit** shall be valid for such a period as the Council thinks fit, but for no longer than a period of 12 months from the date the permit first becomes valid and shall authorise the driver of the vehicle identified by the applicant to leave the vehicle specified therein:
  - (a) in any Permit Parking Place, or part thereof, or any restricted waiting area, or part thereof; and
  - (b) on such day or days, during such periods and at such times during the permitted hours; and
  - (c) subject to such conditions or limitations as are indicated on the permit.
- 33. a Permit shall cease to be valid at the expiration of the period specified thereon, or on the occurrence of any one of the events set out in paragraphs (3)(a), (b), (c), (d) or (e) or (4) of Article 34, whichever is the earlier.

#### Surrender or Withdrawal of Parking Permits or Parking Vouchers

- 34.(1) A Permit Holder may surrender a Permit to the Council at any time and shall surrender a Permit to the Council on the occurrence of any one of the events set out in paragraph (3) of this Article or in accordance with the provisions of paragraph (4) of this Article.
  - (2) The Council or its authorised agent may, by notice in writing served on the Permit Holder by sending the same by the recorded delivery service to the Permit Holder at the address shown by that person on the application for the Permit or at any other address believed to be that person's place of abode, withdraw a Permit if it appears to the Council or authorised agent that any of the events set out in paragraph (3)(a), (b), (d) or (e) of this Article has occurred and the Permit Holder shall surrender the Permit to the Council or authorised agent within 48 hours of the receipt of the aforementioned notice.
  - (3) The events referred to in the foregoing provision of this Article are:
    - (a) the Permit Holder ceasing to be a resident, resident institution representative of entitled business user within the PPZ in respect of which the Permit was issued;
    - (b) the Permit Holder ceasing to be the owner of the vehicle in respect of which the Permit was issued:
    - (c) the withdrawal of such Permit by the Council under the provisions of paragraph (2) of this Article;
    - (d) the issue of a duplicate or replacement Permit by the Council under the provisions of Article 36:
    - (e) the vehicle in respect of which such Permit was issued or attached to being adapted or used in such a manner that it is not a vehicle of the class specified in Article 8;
    - (f) the Permit ceasing to be valid pursuant to the provisions of paragraph (4) of this Article.

- (4) Where a Permit is issued to any person upon receipt of a cheque or credit card and the payment is subsequently dishonoured, the Permit shall cease to be of any effect and the Council or its authorised agent shall by notice in writing served on the person to whom such Permit was issued by sending the same by recorded delivery service to the Permit Holder at an address shown by that person on the application for the Permit or at any other address believed to be that person's place of abode, require that person to surrender the Permit to the Council or within 48 hours of the receipt of the aforementioned notice.
- 35.(1) A Permit Holder who surrenders a Permit to the Council whether before or after it becomes valid will be entitled to a refund of the charges paid proportionate to the expiry date of the Permit. To receive this refund the Permit must be returned and a refund form completed. An administration charge may be levied by the Council for this service.
  - (2) A resident who surrenders unused Resident Visitor Permits within a period of three months after expiration of the date indicated on the Permit will be entitled to Resident Visitor Permits in the same quantity valid for the subsequent year.

# <u>Application for and Issue of Duplicate or Replacement Parking Permits</u>

- 36.(1) If a paper Parking Permit is mutilated or accidentally defaced or the figures or particulars thereof have become illegible or the colour has become altered by fading or otherwise, the Permit Holder shall either surrender it to the Council and apply to the Council for the issue to them of a duplicate Permit and the Council or its authorised agent upon receipt of the Permit, shall issue a duplicate Permit, so marked. Upon such issue the old Permit shall become invalid. An administration charge may be levied by the Council for this service.
  - (2) If a paper Parking Permit is lost or destroyed, the Permit Holder may apply to the Council for the issue to them of a duplicate Permit and the Council or its authorised agent, upon being satisfied as to such loss or destruction shall issue a duplicate Permit, so marked, and upon such issue the old Permit shall become invalid. An administration charge may be levied by the Council for this service.
  - (3) If the vehicle to which a Parking Permit applies changes within the validity of the Permit, the Permit Holder may apply for a replacement Permit with the new vehicle registration or vehicles' registrations. Upon issue of a replacement Permit, so marked, the old Permit shall become invalid. An administration charge may be levied by the Council for this service.
  - (4) The provisions of this Order shall apply to a duplicate or replacement Parking Permit and its application as if it were the original Permit or its application. Charges will not be levied for the first such duplicate or replacement Permit within the 12 month period of validity, but all subsequent applications for a duplicate or replacement Permit will incur the relevant charge as stated in the Schedules contained within the Orders Consolidated by this Consolidation Order.

#### Restriction on the removal of a Parking Permit or Parking Voucher

37. Where a Parking Permit or Parking Voucher, has been displayed on or attached to a motor vehicle in accordance with the provisions of Article 8 of this Order, no person other than the driver of the motor vehicle or a Civil Enforcement Officer shall remove the Parking Permit or Parking Voucher from the motor vehicle unless authorised to do so by the driver of the motor vehicle.

# Power to Suspend use of Parking Places and Permit Parking Places

418 18

- 38. Any person authorised by the Council may suspend the use of a Parking Place or Permit Parking Place whenever they consider such suspension reasonably necessary:
  - (a) for the purpose of facilitating the movement of traffic or promoting its safety;
  - (b) for the purpose of any building operation, demolition or excavation in or adjacent to the

Parking Place or Permit Parking Place or the maintenance, improvement or reconstruction of the Parking Place or Permit Parking Place or the laying, erection, alteration, removal or repair in or adjacent to the Parking Place or Permit Parking Place of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telecommunication apparatus or traffic sign; or

(c) for the convenience of occupiers of premises adjacent to the Parking Place or Permit Parking Place on any occasion for the removal of furniture from one office or dwelling

house to another place; or

(d) on any occasion on which it is likely by reason of some special attraction that any street will be thronged or obstructed; or

(e) for the convenience of occupiers of premises adjacent to the Parking Place or Permit Parking Place at times of weddings or funerals or on other special occasions; or

(f) for the purpose of facilitating the cleansing of the Parking Place or Permit Parking Place; or

(g) on a designated market day for the use by a vehicle being used by a market trader/ street trader for the setting up or breaking down of a licensed market stall.

# Restrictions on the use of Disabled persons parking places as shown in the 'On-Street Plans'

- 39. (a) Save as provided in Article 7 no person shall cause or permit any vehicle to remain in a disabled persons parking place for longer than the maximum period specified for that parking place on the On-Street Plans.
  - (b) Whereas indicated on the On-Street Plans there is a limit on the time of stay on a disabled person's parking place, the driver of the vehicle shall upon leaving the vehicle in the disabled person's parking place, display in the relevant position a disabled person's badge and parking disc, on which has been marked the time at which the period of waiting began and shall remove that vehicle from the said parking place within the maximum time specified.
  - (c) Where a period within which a vehicle must not be left again in a disabled person's parking place is specified on the On-Street Plans, no person shall cause or permit the vehicle to wait again in that parking place until the expiry of that specified period.

#### **Penalty Charges**

- 40. (1) Where a person contravenes the prohibitions and requirements set out in the provisions of this Order, the owner of the vehicle in question shall incur a penalty charge.
  - (2) The penalty charge shall be payable to the East Hertfordshire District Council in accordance with the instructions contained on the penalty charge notice.
- 41. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the Interpretation of an Act of Parliament.
- 42. The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any other regulations made or having effect as if made under the 1984 Act or by or under any other enactment.
