**EAST HERTFORDSHIRE DISTRICT COUNCIL (EAST HERTS RURAL)
(OFF-STREET PARKING PLACES) ORDER 2014 (AMENDMENT) ORDER 2023**

The East Hertfordshire District Council with the consent of Hertfordshire County Council under Section 39 of the Road Traffic Regulation Act 1984 (“the 1984 Act”) and under arrangements made with Hertfordshire County Council pursuant to Section 19 of the Local Government Act 2000 and the Local Authorities (Arrangements for the Discharge of Functions) (England) Regulations 2000 and in accordance with the provisions of Part 6 of The Traffic Management Act 2004 (“the 2004 Act”) under the powers conferred by Sections 1, 2, 4, 32, 35, 46 and Parts IV and V of Schedule 9 of the 1984 Act and Section 74 of the Road Traffic Act 1991 (as modified by the Road Traffic (Permitted Parking Area and Special Parking Area) (County of Hertfordshire) (East Hertfordshire District Council) Order 2005 and of all other enabling powers, after consultation with the Chief Officer of Police hereby makes the following Order:-

1. This Order shall come into operation on **8 April 2024** and may be cited as "East Hertfordshire District Council (East Herts Rural) (Off-Street Parking Places) Order 2014 (Amendment) Order 2023".
2. This Order amends the ‘East Hertfordshire District Council (East Herts Rural) (Off-Street Parking Places) Order 2014’ (herein after referred to as ‘the East Herts Rural 2014 Order’) as follows;
 - (a) It removes the Off-Street Plan identified as RCP 02/02 from the East Herts Rural 2014 Order and replaces it with a new Off-Street Plan identified as RCP 02/03 incorporating the plan into the East Herts Rural 2014 Order.
 - (b) It removes Article 1 (b) and replaces it with a new Article 1 (b) as follows;

‘The East Hertfordshire District Council East Herts Rural Off-Street Parking Place Plans (“the Off-Street Plans”) identified as RCP 01/04, RCP 02/03 and RCP 03/04 are incorporated into this Order.’
 - (c) It removes Row 2 (relating to High Street, Stanstead Abbots) of the Schedule 1 table and replaces it with a new Row as follows;

3. The provisions of the following Order are hereby revoked but only in so far as they are affected by this Order;

4. The interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

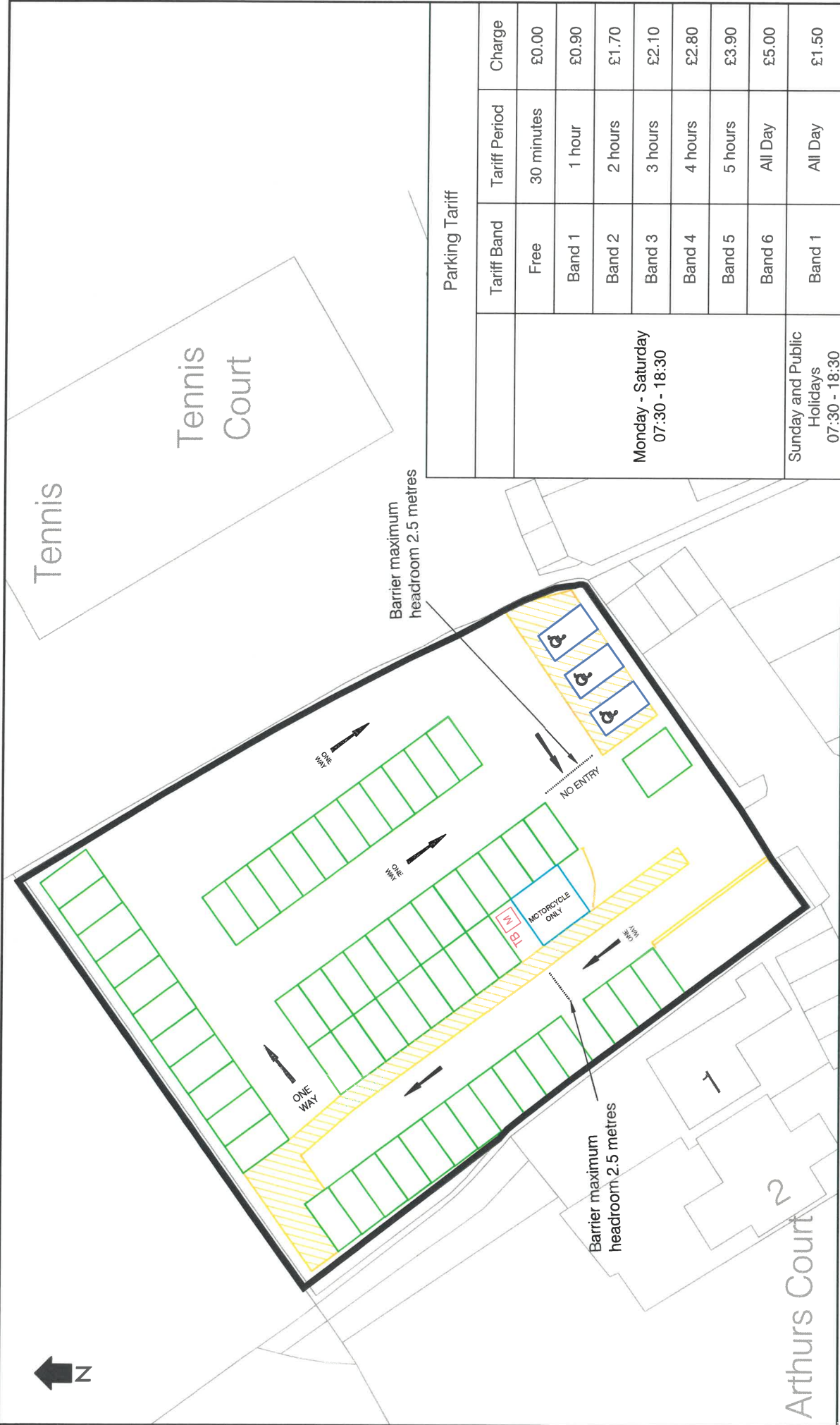

NOTICE IS HEREBY GIVEN that the East Hertfordshire District Council with the consent of Hertfordshire County Council has made the above Order under the Road Traffic Regulation Act 1984. The general effect of the Order will be to restructure the car park tariff and alter the bay allocation in High Street, Stanstead Abbots. The Order will come into effect on **8 April 2024**.

Documents giving more detailed particulars of the Order are held on deposit and may be viewed from **8 April 2024 to 23 May 2024**, during normal office hours, at East Hertfordshire District Council, Wallfields, Pegs Lane, Hertford SG13 8EQ. **STATEMENT OF REASONS FOR PROPOSING
EAST HERTFORDSHIRE DISTRICT COUNCIL (EAST HERTS RURAL)
(OFF-STREET PARKING PLACES) ORDER 2014 (AMENDMENT) ORDER 2023**

Following the cessation of funding from corporate sponsor French & Jupps a review was undertaken regarding East Herts Off-Street Parking Places in High Street Stanstead Abbots car park. East Hertfordshire District Council proposes to amend its 2014 East Herts Rural Off-Street Parking Places Order. The amendment Order will introduce a new charging structure and alter parking bay allocations within the car park.

The general effect of the Order will be to:

- Introduce a new long and short stay charging structure Monday to Saturday and a flat rate fee on Sunday and Public Holidays (excluding Christmas Day).
- Alter the Days and Hours of operation of the car park.
- Convert the existing 3-hour free parking bays and limited waiting parking bays to long and short stay pay and display parking bays.

The proposals have been agreed by the Members of East Hertfordshire District Council and have been subject to consultation with Hertfordshire County Council. The local Police, Fire and Rescue Service have also been consulted.
