

- 1. On the 2 May 2019 The East Riding of Yorkshire Council made this Order which will be operative from the 2 May 2019 to amend The East Riding of Yorkshire Council (On Street Parking Places) (Civil Enforcement) (Consolidation) Order 2017 the effect of which will be:-
  - (a) To introduce a School Keep Clear Mandatory No Stopping Restriction from Monday to Friday between 8.30am and 9.30am and between 3pm and 4pm on Main Street, Paull and Dorset Avenue, Skirlaugh

(b) To introduce a Mandatory No Stopping Restriction from Monday to Friday between 8.30am and 9.30am and between 3pm and 4pm on the length of the Bus Stand on Dorset Avenue, Skirlaugh

(c) To introduce No Waiting at Any Time restrictions on parts of Benningholme Lane, Dorset Avenue and Chapel Close, Skirlaugh
