The East Riding of Yorkshire Council (hereinafter referred to as “the Council”) in exercise of its powers under Section 1 of the Road Traffic Regulation Act 1984 (hereinafter referred to as “the Act of 1984”) as amended and in pursuance of powers granted by the Secretary of State under Section 74 and Part 2 of Schedule 8 and under Paragraph 8 of the Traffic Management Act 2004 (hereinafter referred to as “the Act of 2004”) as amended and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 hereby makes the following Order:-

1. This Order shall come into operation on the 14th day of 2018 and may be cited as The East Riding of Yorkshire Council (On Street Parking Places) (Civil Enforcement) (Consolidation) (Amendment No.9) (Prohibition of Waiting and Loading, Disabled Parking Bays, Loading Only, Various Streets, Driffield) Order 2018.
2. The East Riding of Yorkshire Council (On Street Parking Places) (Civil Enforcement) (Consolidation) Order 2017 is hereby amended to the following extent:
 - (a) The Plan Tile References specified in Schedule 1 (Parkmap Schedule 24.01) to this Order are hereby revoked and:
 - (b) The Plan Tile References specified in Schedule 2 (Parkmap Schedule 25.01) to this Order are hereby inserted.

1. On the 12 June 2018 The East Riding of Yorkshire Council made this Order which will be operative from the 14 June 2018 to amend The East Riding of Yorkshire Council (On Street Parking Places) (Civil Enforcement) (Consolidation) Order 2017 the effect of which will be:-

- (a) To introduce No Waiting and No Loading at Any Time on parts of Victoria Road, Driffield
- (b) To introduce No Waiting at Any Time on parts of Church Street, on parts of Victoria Road, Driffield
- (c) To introduce No Loading at Any Time on parts of Middle Street South, on parts of Market Place, parts of George Street and parts of Cranwell Road, Driffield
- (d) To introduce disabled parking bays for use Monday to Saturday for 2 hours with no return within 1 hour on parts of Middle Street South, Driffield
- (e) To introduce a Loading Only Bay on part of Middle Street South, part of Market Place and part of Cranwell Road, Driffield
- (f) To remove the existing Non-Mandatory School Keep Clear Markings on Victoria Road, Driffield
- (g) To introduce a disabled parking bay for 3 hours with no return within 3 hours on part of Cranwell Road, Driffield

2. A copy of the Order and relevant plans may be examined during normal office hours at the Driffield Customer Service Centre, Driffield Centre, Cross Hill, Driffield, YO25 6RQ and Beverley Customer Service Centre, Cross Street, Beverley, HU17 9BA. (Ref MG/77043)

3. If you wish to question the validity of this Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of that Act or any instrument made under it has not been complied with in relation to the Order, you may, within six weeks from the 14 June 2018 apply to the High Court for this purpose.
