The East Riding of Yorkshire Council (hereinafter referred to as “the Council”) in exercise of its powers under Section 1 of the Road Traffic Regulation Act 1984 (hereinafter referred to as “the Act of 1984”) as amended and in pursuance of powers granted by the Secretary of State under Section 74 and Part 2 of Schedule 8 and under Paragraph 8 of the Traffic Management Act 2004 (hereinafter referred to as “the Act of 2004”) as amended and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 hereby makes the following Order:-

1. This Order shall come into operation on the 3<sup>rd</sup> day of September 2018 and may be cited as The East Riding of Yorkshire Council (On Street Parking Places) (Civil Enforcement) (Consolidation) (Amendment No.12) (Various Streets, Beverley) Order 2018.
2. The East Riding of Yorkshire Council (On Street Parking Places) (Civil Enforcement) (Consolidation) Order 2017 is hereby amended to the following extent:
  - (a) The Plan Tile References specified in Schedule 1 (Parkmap Schedule 24.01) to this Order are hereby revoked and:
  - (b) The Plan Tile References specified in Schedule 2 (Parkmap Schedule 25.01) to this Order are hereby inserted.





1. On the 3<sup>rd</sup> September 2018 The East Riding of Yorkshire Council made this Order which will be operative from 3<sup>rd</sup> September 2018 the effect of which will be to
  - (a) Introduce a clearway extension on Hull Road and introduce & remove waiting restrictions on Hull Road, Beverley Parklands, Rice Close & Brookholme, Beverley.
  - (b) Amend the existing restrictions on Long Lane, Beverley.
  - (c) Replace a section of No Waiting at Any Time restrictions with Controlled Parking Zone bay on Wood Lane, Beverley.
  - (d) Replace a section of Controlled Parking Zone bay with No Waiting at Any Time restrictions on Woodlands Drive, Beverley.
  - (e) Introduce No Loading at Any Time restrictions & replace a section of Controlled Parking Zone bay with No Waiting at Any Time restrictions on Lairgate, Beverley.
  - (f) Introduce No Waiting at Any Time restrictions on Beckside North, Beverley.

3. If you wish to question the validity of this Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of that Act or any instrument made under it has not been complied with in relation to the Order, you may, within six weeks from the 3<sup>rd</sup> September 2018 apply to the High Court for this purpose.
