The East Riding of Yorkshire Council (hereinafter referred to as “the Council”) in exercise of its powers under Section 1 of the Road Traffic Regulation Act 1984 (hereinafter referred to as “the Act of 1984”) as amended and in pursuance of powers granted by the Secretary of State under Section 74 and Part 2 of Schedule 8 and under Paragraph 8 of the Traffic Management Act 2004 (hereinafter referred to as “the Act of 2004”) as amended and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 hereby makes the following Order:-

1. This Order shall come into operation on the 25th day of October 2018 and may be cited as The East Riding of Yorkshire Council (On Street Parking Places) (Civil Enforcement) (Consolidation) (Amendment No.20) (Flat Lane, Barmby Moor) Order 2018.
2. The East Riding of Yorkshire Council (On Street Parking Places) (Civil Enforcement) (Consolidation) Order 2017 is hereby amended to the following extent:
 - (a) The Plan Tile Reference specified in Schedule 1 (Parkmap Schedule 24.01) to this Order is hereby revoked and:

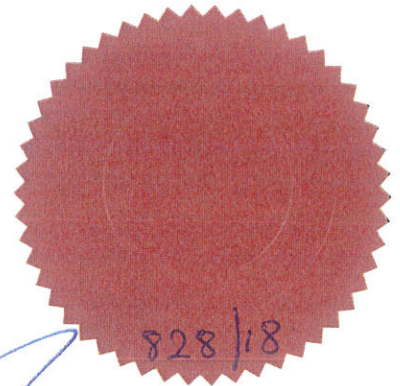

On the 25 October 2018 The East Riding of Yorkshire Council made this Order which will be operative from the 25 October 2018 to amend The East Riding of Yorkshire Council (On Street Parking Places) (Civil Enforcement) (Consolidation) Order 2017 the effect of which will be to introduce School Keep Clear No Stopping from Monday to Friday between 8.00am and 9.00am and between 3.00pm and 4.00pm on part of Flat Lane, Barmby Moor.
