The East Riding of Yorkshire Council (hereinafter referred to as “the Council”) in exercise of its powers under Section 1 of the Road Traffic Regulation Act 1984 (hereinafter referred to as “the Act of 1984”) as amended and in pursuance of powers granted by the Secretary of State under Section 74 and Part 2 of Schedule 8 and under Paragraph 8 of the Traffic Management Act 2004 (hereinafter referred to as “the Act of 2004”) as amended and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 hereby makes the following Order:-

1. This Order shall come into operation on the 25th day of October 2018 and may be cited as The East Riding of Yorkshire Council (On Street Parking Places) (Civil Enforcement) (Consolidation) (Amendment No.21) (Balne Moor Road, Pollington) Order 2018.
2. The East Riding of Yorkshire Council (On Street Parking Places) (Civil Enforcement) (Consolidation) Order 2017 is hereby amended as specified in the Schedule to this Order.

1. On the 25 October 2018 The East Riding of Yorkshire Council made this Order which will be operative from the 25 October 2018 to amend The East Riding of Yorkshire Council (On Street Parking Places) (Civil Enforcement) (Consolidation) Order 2017 the effect of which will be:-

- (a) To reduce the length of the Mandatory School Keep Clears No Stopping Monday to Friday between 8.15am and 9.15am and between 3.00pm and 4.00pm on Balne Moor Road, Pollington.
- (b) To remove the Coaches Clearway area on Balne Moor Road, Pollington.

2. A copy of the Order and relevant plan may be examined during normal office hours at the Goole Customer Service Centre, Council Offices, Church Street, Goole, DN14 5BG and Beverley Customer Service Centre, Cross Street, Beverley, HU17 9BA. (Ref MG/77415)

3. If you wish to question the validity of this Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of that Act or any instrument made under it has not been complied with in relation to the Order, you may, within six weeks from the 25 October 2018 apply to the High Court for this purpose.
